The pre-meeting was called to order at 7:00PM.

Attorney Maura O'Keefe discussed with the board the most resent updates to the regulations. Attorney O'Keefe suggested changes made by the Program and Services committee. The first change made to the subs section of the application. What do you with an application that hasn't been through the application process? It's missing that one section of the vetting procedure that is going to be put in place. It's for those lodging houses that are out there that would be grandfathered. The suggestion was to add to the regulation that the board can solicit testimony from anyone that the boards sees as a benefit to make a decision. A decision maker will be from an appropriate department. The request would be by email to attend the licensing hearing. Second change in the regulation was that the numerical footage was removed so not affect the abutter notification changes. Third change in the regulation was from the City Council Program and Service, if the registered agent or owner / licensee of the property fails to show for a disciplinary hearing it could result in a penalty. The ordinance has been passed and now there will be a public hearing to allow comments. After the public hearing the regulation will be amended.
