The June 19, 2018 minutes were approved 3-0.

POLICE DETAIL DISCUSSION

Lieutenant George McMains, Newton Police Liaison, discussed that there were potential issues with the way Boston College (BC) was having their events and how they were notifying the Local Board and Police. Lt. McMains sat down with the BC's Director of Public Safety, several BC Police Officers, Director of Public Events and other directors. BC has a caterer's license and do not have to come to a hearing for a one-day license. There was concern around a notification in June with an attendance of 150 people with no police, 200 people with no police and 350 people with no police. Lt. McMains sat with the departments to make sure that BC is complying with the rules and regulations set forth by the Licensing Commission. The directors assured Lt. McMains that they are complying with the rules. Police details will be filed with BC Police first and then will reach out to Newton Police if the details could not be filled by BC personnel. Lt. McMains spoke to BC's Lt. Speiss, who oversees the people who do the details. BC has patrol supervisors checking in to make sure detail officers are doing their duties. All serving alcohol are TIPs certified. Lt. McMains stated that Newton Police will do spot checks during these events. Commissioner McCarthy asked that these notifications be forward to the Commission. Lt. McMains stated that it is up to BC's discretion to the number of details needed according to the type and attendees of an event.
