MINUTES

DATE: February 21, 2017

PRESENT: Commissioners Kathleen McCarthy, Dina Conlin

The meeting was called to order at 7:15PM.

The January 17, 2017 minutes were approved 2-0.

The liquor licensing template used for licensees in good standing was presented. The format was checked by the Commissioners and approved 2-0.

Discussion on BYOB:

An email from Commissioner Gloria Gavris was read into the record regarding BYOB. After reviewing the current minutes she felt they should not revise the current policy at this time and continue the prohibition in the City of Newton by not allowing BYOB. Several cities and towns allow BYOB due to no liquor licenses being available. Fourteen (14) alcohol licenses are currently available in the City of Newton. Commissioner Gavris believes that all alcohol and beer/wine licenses are preferable because of regulatory, public safety framework under which they operate are good. If the other Commissioners disagree she would agree to support BYOB proposals in small restaurants. She feels all regulations could be put into place to find a solution that would benefit all. At this time she does not support BYOB. Her email will be attached to these minutes.

Councilman Alison Leary Supports BYOB. Her email was read into the record. She felt that the smaller 20-25 seat restaurants would thrive. Regulations should be put into place like tips certification, proper insurance and specific hours like Boston. She felt the fee should be \$400.00 dollars. This would attract a clientele that would benefit all. She would like to lift the ban and make BYOB more affordable.

Josh Ehrenfried, a Newton Resident, supports BYOB. His email was read into the record.

Commissioner Dina Conlin agrees with Commissioners Gavris's view. A lot of restrictions would be needed and there is not a lot of business support. It would take a lot of work to regulate it. She does not support BYOB at this time.

Commissioner Kathleen McCarthy feels BYOB could work. She felt if you looked at the economics there is a certain hardship for the small business owners. She would only consider a two out of three Majority vote in order to consider.

Commissioner Conlin commented that in the future they could revisit BYOB. She is not leaving the door closed for the future but due to the business response at this time she would not recommend it.

Attorney Maura O'Keefe mentioned the statutory frame work may change in the future for BYOB and it will be a wait and see process. She would like to request a meeting with the staff to discuss fees. She would like to discuss the staff's views and the renewal processes. She has other topics to discuss as well. She would like to invite Commissioner Robert DeRubeis from Parks and Recreation to speak about one day licenses. She would like the administrative staff to arrange

the meeting during the day as soon as possible.

2-0 vote BYOB will not continue at this time with consideration of Commissioner Gloria Gavris's comments via email.
