#### Minutes

The meeting was called to order at 7:00PM.

Discussion on updated check lists were approved 2-0, updates may be made in the future. All current checklists are posted on line.

Discussion on Special Hearings: The Commissioners decided to write a policy for special hearings and to have it posted online and given to the applicant during the application process. Extraordinary circumstances on a case by case basis should be presented to the Commissioners.

Commissioner McCarthy discussed how she spoke with legal counsel regarding existing liquor license holders applying for one day temporary alcohol licenses. It was determined that they would need to apply for an alteration of premises. She spoke about how the board can put conditions on these licenses such as hours, location, noise levels, etc.

The special meeting with staff on March 21, 2017 was discussed in regards to reviewing the policy for Parks and Recreation. The Commissioners did receive the policy which they felt was out dated. They are requesting a discussion to be put on the August agenda regarding late fees and penalties, as well as touching base with legal counsel on the Parks and Recreation policy.

The March 23, 2017 minutes were approved 2-0.

The April 11, 2017 and April 28, 2017 minutes will be reviewed at the next hearing.
