#### **MINUTES**

Meeting called to order at 7:11 pm

August 16, 2016 Minutes – approved 2-0, Commissioner Conlin abstained because she was not present for the August meeting.

## Brief discussion regarding hearing schedule.

The 2017 hearing schedule review was rolled over to the October 25, 2016 hearing.

## Discussion on recent incident at The Hotel Indigo.

Sgt. McMains described an incident at Hotel Indigo on 8/14/16 during a pool party, and referring to a police report. The commissioners inquired of any other incidents. The commissioners requested the Hotel Indigo be put on the agenda for May 2017 in advance of next season regarding parties as a follow up to tonight's discussion in order to discuss a plan of what they are doing for party planning. Later during the meeting, when City Councilor Lenny Gentile spoke in favor of the applications filed by Ward 4 LLC, he informed the commissioners that Hotel Indigo has a special permit and suggested they review a copy. The commissioners requested copy of the Special Permit for the Hotel Indigo to review the conditions.

#### Discussion of Keno parlor monitor at Highland Farms 69 Waltham Street Newton.

Attorney O'Keefe explained that there are approximately 30 Keno machines in the City of Newton. There is a statutory requirement for the local Board of License Commissioners to receive notice of new applications filed with the State Lottery Commission. The local Board can decide whether or not to object to the permit application. If there are no objections, no action is taken at the local level. Future Keno notifications will need to be posted on the Newton Board of License Commissioners meeting agendas. The Commissioners voted 3-0 that they have no objections to this application, so no action is required.

## Continuation of the discussion of BYOB: Bring Your Own Bottle

The commissioners discussed a need for a forum to which best to discuss BYOB. The commissioners discussed having an opportunity for public to comment at the October and November meetings. The commissioners requested that other businesses be invited to the hearing to discuss. Letters should be sent to Common Victualler license holders notifying them of the hearings. An ad should be put in the Newton Tab for the public. Additional groups could also include city councilors, the Chamber of Commerce, the Restaurant Association and area/village councils. Attorney O'Keefe will draft a letter to be sent out and collect a list of who should receive those letters. The commissioners discussed having the open hearing at 6:30pm to give time to discuss this matter. The Commissioners also would like to provide the opportunity for anyone to

comment by email too. Attorney O'Keefe reminded the Commissioners that she has suggested Police Chief MacDonald provided input as well. Sargent McMains said the Police Dept. has concerns about BYOB.
