The burden is on the public to know the regulations and find the schedule of the regular meetings.

Classifications on Non-Profit Organizations- 501 organizations that qualify as charitable by the IRS shall be considered non-profit.

Regulations state 1 day temporary alcohol licenses can be granted to non-profit organization only – not to individuals. Perhaps a checklist can be added to the application to show what is necessary to prove non-profit status. Some establishments do not accept out-of-state driver's license. If an establishment believes a person is close to legal purchase age and has an out-of-state license, they can refuse the sale.
