Representatives from Auburndale Wine and Spirits introduced themselves to the board to discuss violations the occurred on April 23, 2015.

Sgt Cupoli read the report of violation from Newton Police regarding underage alcohol purchase.

Auburndale Wine and Spirits responses: They have been operating for 21 years without a single violation. They do not dispute the findings in the Newton Police Department. Going forward no out of state licenses will be accepted and increased signage will be posted. Everyone appearing under age of 30 will be asked for ID. All Groups will be asked for ID. The employee that violated the policy was given one month's suspension. All employees must use the scanner for all ID's. Scanner has been in place for approx. 3 years. Retraining of all employees plus a TIPS recertification from a 3<sup>rd</sup> party company has begun. A sincere apology was given to the board with assurance it will not happen again. Commissioner Conlin suggested a policy manual should be developed with an employee signature acknowledging they understand the policy and understand the ramifications if not followed.
