#### Licensing Board Agenda:

The meeting was called to order at 7:08 pm and introductions were made.

## \*APPROVAL OF MINUTES FOR OCTOBER 21, 2014\* Approved 2-0

Maura O'Keefe of the Law Department began the discussion portion of the meeting. She said has been reviewing application forms and instructions for one-day licenses. She suggested a flow chart for whether or not someone needs a one-day license. Maura will email what she has come up with for feedback/discussion during the next meeting.

Commissioner Gavris asked if the new form will be done by Jan. 1. Ms. O'Keefe said that's the goal and gave examples of how the chart works.

On a separate matter, Commissioner Gavris clarified that if someone comes in having already chosen a caterer on the ABCC list, they don't need a license from us. Ms. O'Keefe said yes, and said she would also email the commissioners the list of responsibilities caterers are expected to fulfill. The group briefly discussed this.

Ms. O'Keefe said she has new information to share about Commonwealth Wine and Spirits, and the group discussed whether or not the owner, Mr. Giannopoulos, would be coming to the meeting. She said that because the owner doesn't have a property interest or address anymore, he is unable to renew his license that will expire at the end of the calendar year. Renewals are due Nov. 30. Ms. O'Keefe described the situation as a "pocket license" which means he has no business location attached to the license. Ms. O'Keefe said the owner also provided incorrect information about when his business closed. Ms. O'Keefe recommended that the Board inform Mr. Giannopoulos that his license is nonrenewable because he doesn't have a location to put on his application, and said he Board is better off not approving a renewal than revoking his license so as not to trigger an appeal process.

Ms. Conlin asked what the Board could do if the owner had a purchase and sale agreement tonight. Ms. O'Keefe said it would be ok to give the owner until the renewal deadline of Nov. 30 to renew. Ms. Gavris said they would call the item for the end of the night.

Ms. O'Keefe said the Board has some policy decisions regarding fees to make in the future. The Programs & Services Committee has questioned whether this Board should entertain idea of offering discount fees for nonprofit organizations. Ms. O'Keefe said she would email a memo the Board used the last time fees were revised that explains the considerations for how fees are established in the city. The commissioners agreed to discuss fees during the business portion of the next Board meeting. And the commissioners would like a separate portion of the minutes with future agenda items listed so they're easier to spot.

The commissioners discussed the BNTT d/b/a Value Market and Gas store which is in violation of its construction permit. Ms. O'Keefe explained that the Board isn't expected to have information from other department at the time of license approvals, which is why they are conditional. Debra Gentile acknowledged that the office staff does not issue permits until all other departments have signed off on them. Ms. Gentile departed the meeting, and Sgt. Cupoli arrived.

\*CESSATION OF OPERATION FINAL DECISION – APPETITO'S (JASPER TISDALE)\*

No action taken. A representative, Mr. Lawrence Lee, of the landlord, said the landlord has been unable to reach Mr. Tisdale as well. The commissioners decided to take no action and to let the license expire.
