SUBMISSION DEADLINES

Requests to be on a specific agenda and written materials for the CPC's pre-meeting packet must be received by the **pre-meeting deadlines listed below**.

However, **any full proposal the CPC agrees to consider "off cycle"** (before or after normal annual deadlines) is due **1 month prior to the date requested for the CPC public hearing** on that proposal. "Off-cycle" consideration must be requested when submitting the project's pre-proposal and must be agreed to in advance by the CPC.

The public is welcome at all Community Preservation Committee meetings.

Time is reserved for public comment on designated **public hearing** items. Public comments may be taken on other items at the chair's discretion.

Meeting locations are handicap accessible.
