PUBLIC HEARING 17 November 2010, 6:30 pm, Newton Senior Center

CITY ARCHIVES Engineering Plan & Map Collection Preserve and digitize the oldest and most fragile engineering maps and plans that the City is legally required to retain. The project will provide backup records as part of disaster recovery planning, and reduce the chance of further deterioration caused by active use, and allow access to the data from these maps through the City's geographic information system. *CP funds requested: \$1,903,000 Total project cost: \$2,241,534 Non-CP funding sources: None listed. Project Manager: Darrell Azure, Engineering Archivist, City of Newton Dept. of Public Works.*

112-116 DEDHAM STREET (housing) Create 4 deed-restricted 2-bedroom units for sale to homeowners at 80 percent of the area-wide median income, in a 16-unit, mixed-income development that incorporates a 19th-century stone barn. *CP funds requested: \$1,400,000 Total project cost: \$8,940,000 Non-CP funding sources: Developer equity \$780,000; private bank loan \$6,700,000. Project Manager: Geoffrey Engler, S-E-B, Ltd.*

EARLY ARCHITECTURE SURVEY, 1830-1840 Correct and expand existing partial surveys of Newton's earliest buildings, to guide regulatory preservation, including the demolition delay, as well as future decisions about preservation funding. Some significant early buildings have been lost since previous surveys were done; and the City's current information about many of its oldest buildings is either inaccurate or inadequate. *CP funds requested: \$37,500 Total project cost: \$65,333 Non-CP funding sources: \$27,833, including \$16,700 grant from Massachusetts Historical Commission and contributed Planning Dept. staff time. Project Manager: Katy Holmes, Preservation Planner, City of Newton Planning Dept.*

PUBLIC HEARING 15 December 2010, 7 pm, City Hall Cafeteria (Basement)

HISTORIC BURYING GROUNDS, 2B: Tomb Repair & Conservation Conservation, repair, stabilization, and cleaning of approx. 30 historic tombs and erection of historically appropriate ornamental fences around the East Parish, West Parish, and South Burying Grounds. *CP funds requested: \$614,461 Total project cost: \$1,060,133, including previously appropriated CP funding of \$445,672. Non-CP funding sources: none, although the Jackson Homestead (a City dept.) and Newton Historical Society (private nonprofit) fund educational & interpretive programs, and volunteer groups assist with maintenance. Project Manager: Laura Costello, Newton Historical Society.*

61 PEARL STREET (housing) Create 3 units of permanently affordable rental housing, each with 2 bedrooms, for households at up to 50 percent of area-wide median income, in a building that dates to approximately 1870. The first-floor unit will be fully accessible. *CP funds requested: \$665,000 Total project cost: \$1,370,000 Non-CP funding sources: \$130,000 CDBG; \$350,000 HOME, \$175,000 bank loan, \$50,000 foundation grants Project Manager: Josephine McNeill, Executive Director, CAN-DO.*
