Re: Bowen Park Initiative

The Bowen Thompsonville Neighborhood Association (BTNA) Board enthusiastically supports the **Bowen Initiative's** proposal for CPA funding. As a neighborhood, which has been increasingly encroached upon by large-scale development, rarely do we have the opportunity to support a project within our community. However, we can and do support this project. We feel the physical improvements to the infrastructure of the Bowen Elementary School playground and surrounding areas, as well as the creation of an environmental learning center within our neighborhood, would be extremely beneficial to this community.

The association attempted to save the woods that belonged to Andover Newton Theological School when no CPA funds/ law were available. This land was used by neighbors on walks, by pet owners and children as well as a variety of wildlife. The association lobbied for inclusion in the Special Permit granted to subdivide the land, a provision to require the developer to rectify the drainage problems on the upper field, assuming it would also solve the problems at the school playground. This developer cannot now be forced to expend funds to solve this mess.

Because of our mutual concerns for traffic, safety and the devastation of the woods, the BTNA and the Bowen School have worked together for many years. Resolving the drainage problems on the playground is a necessary step to making this area safe and usable for the children on the playground.

Many neighbors use this space including young families with pre school aged children, residents of the Hamlet, as well as young families from lands such as Korea, Vietnam, Russia, Israel, India, who meet, or picnic, and have a place to connect while their children enjoy playing with the facilities there and to connect with others like themselves. Children from other Newton villages also have an opportunity to enjoy themselves in the playground when they or their siblings come to play in organized league sports on the upper field.

The Initiative's plan to expand the environmental educational component of the school's curriculum will be a model for the "Garden City" and provide a great opportunity for suburban children to have a role in protecting their local habitats as well as giving them a greater appreciation of the environment.

We urge you to support this worthy and well conceived proposal.

The Bowen Elementary Schoolyard Initiative has a "green school" component that we at the Green Decade Coalition wholeheartedly support. Their plans to begin a school-wide composting program and to install rain barrels to collect roof run-off are two practices that ought to save the school money, instill a sense of "conservation common sense" in the student body, and possibly inspire other schools to begin their own programs. Further, we support the Initiative's commitment to grow grass without irrigation or pesticides, and their desire to rid the woods behind the school of exotic invasive plants, and fill them instead, with native plants, many of which are endangered.

Further, the Initiative plans to develop academic tie-ins across the curriculum, but particularly to science and social studies. We support the idea of integrating experiences of nature, horticulture, fresh food, and conservation into the daily lives of our children, rather than relegating them to camp or weekends away or the occasional field trip. We understand that the Initiative is working with the Science Curriculum Coordinator for the city of Newton and the Educational Outreach Coordinator of Angino Farm, as well as some teachers from Bowen Elementary to make the outdoor classroom curriculum meet standards-based requirements. Again, this could inspire other schools in Newton to begin comparable programs.

The way that CPA funding would energize an already enthusiastic teaching staff, PTO, and administration should not be underestimated.

I am writing in support of the Bowen Elementary Schoolyard Initiative.

Bowen Elementary School has served as an official Project Partner Site for the "NewtonSERVES Day of Community Service" on two occasions. In both instances, the volunteers were recruited to help restore or maintain the school grounds – mulching, weeding, and fertilizing trees and shrubs. One year our volunteers planted an island of native shrubs at the end of a wheelchair ramp. The plantings were paid for by the Bowen PTO and were meant to attract and feed birds, as well as to capture some of the run-off from the building that pools just below the plantings.

The project liaison, Dee Mallon, has said that she hopes that Bowen Elementary can be a site for NewtonSERVES again next year, so that citywide volunteers can again join the school in their efforts to remove invasive exotic plants from the woods. Dear Ms. Goldson:

I am writing on behalf of the Newton School Committee in strong support of the application of the Bowen Elementary Schoolyard Initiative for Community Preservation Committee funding. This group proposes to remedy drainage problems behind the school and prevent run-off from the nearby Newton Terraces project, create outdoor seating and walkways within the playground, remove poison ivy and non-native plantings from the woods, and to plant trees and other native plantings in the woods and playground. This initiative is designed to benefit the neighborhood by creating a playground area with seating for adult supervision and by restoring the woods for walking.

The proposal involves the Bowen Parent Teachers Association but also the Thompsonville Neighborhood Association and the Bowen student body. The PTO has pledged \$13,000 and expects to receive city funding for playground equipment. They are also applying for grants but seek CPA funding for environmental improvements including drainage, plant and tree removal, and planting activities.

The Bowen school already has in place an extensive outdoor curriculum, which it is seeking to expand. The wooded area behind the school had been an important component of this environmental/science curriculum but has not been able to be implemented in recent years due to the poison ivy and other blight to the woods.

The School Committee endorses this proposal, which will benefit the neighborhood, the city, and the school community. We hope you are able to provide funding for this creative initiative that holds much promise.

I am happy to write this letter in support of the *Bowen Schoolyard Initiative* which aims to improve recreation and education opportunities for Bowen students, and create an attractive and inviting outdoor space to be enjoyed by community residents as well.

The community served by this playground includes over 300 families whose children attend Bowen Elementary School, local residents and their pre-school children and grandchildren, and dog walkers and others who use it for exercise.

Currently, Bowen faces several challenges which need to be addressed: drainage problems cause playground flooding, often prohibiting use of the play area for long periods after major rain and snow melt. In addition, grass is unable to grow in this area, causing a dust bowl effect that further limits playground use throughout the dry seasons. The woods surrounding the play area have been overtaken by invasive plants, including poison ivy, which have destroyed the "outdoor classroom" environment that the woods once provided.

Specifically, the grant money would be used to:

- fix the drainage problems;
- replace aging playground equipment;
- · repair the woods by introducing native plants and removing invasives;
- create a lovely and educational walking path;
- place benches and tables for people to relax; and
- build a mini-amphitheatre for outdoor classroom use.

I am the Director of the Bowen After School Care Program, located here at the Bowen School. Each afternoon for over thirty years, children have poured out the doors of the school to enjoy freedom and physical activity on the playground. Neighborhood children join the after schoolers playing baseball, swinging, sliding, and climbing on the bars, visiting, and chasing one another in the open space. It is a social time, providing relaxation or the release of pent up energy.

Our after school program has served over 1,850 families and 2,250 children, all of whom have used the Bowen playground daily throughout the seasons. We have used the woods as an outdoor classroom, for scavenger hunts, and even tapped maple trees for syrup. The hill has served as a stage for plays and poetry. I am writing to support the Bowen Park Initiative. I live one house away from Bowen on Cypress Street, and the Bowen schoolyard abuts the entire width of my backyard. I have occupied this house since 1975 (30 years) and have had ample experience with the problems the school faces with its space.

Drainage Problems

The drainage problems are serious. It is important to me to have the drainage problem finally corrected. When heavy rains occur (or with frequent rains), my yard can flood to a depth of almost six inches at its far end where it meets the schoolyard. And, I can easily see the large pool of water that rests in the schoolyard at such times.

The development of Andover Newton Theology School Hill has only made this problem worse. I have photographs of water rooster tailing out of street sewers, two feet deep in my neighbor's driveway (they own the house next to Bowen), and ducks swimming on the upper field above Bowen.

Shade Trees and Seating

I thoroughly support the creation of shade areas and seating at Bowen. I love watching families with their children use the schoolyard and it has always bothered me that there is no place for parents to sit in the shade.

It further concerns me that the existing shade under the large oak at the edge of the schoolyard by my backyard is so dangerous. Oaks are weakened by standing water (the drainage problem again) and this very large oak has shed two major branches (one foot plus in diameter) in the past years. One landed in the schoolyard and scratched two fleeing children. Luckily no one was seriously hurt in either incident. However, without pruning and care to stop the flooding, this shade tree may prove to be a liability to the city rather than the boon it should be.

Dear Ms. Goldson,

I am a Professor of Education and Coordinator of Community Partnerships at Lesley University, and a resident on Cypress Street in the Bowen-Thompsonville district. Living in Newton for the past 30 years, I have been an active member of the community for the last 10 years.

In 2003, with the support of the Bowen School community, I organized a Tree Ceremony to honor the felled trees on the southern slope of the Andover Newton Theological School campus. Working closely with the school principal, Dr. Patricia Kelly, and the art teacher, Amber Wenger, I learned first-hand about this school's commitment to developing a strong, ecologically-informed student body. The school's pledge to integrate ideas about ecology into the curriculum was fairly unprecedented at that time, as was their willingness to launch new partnerships with community members to achieve this end.

Bowen has an impressive parent network that grows out of the school's willingness to work collaboratively with families. It comes as no surprise that the Bowen Initiative is conceived of as a plan that would benefit both the school and the community. The schoolyard is the place where children and families congregate. The informal nature of coming together in those "off-hours" is extremely important to the concept of building strong communities. The items identified in the Bowen Initiative proposal are modest and basic to improving the immediate environment. In addition, these initiatives will form the basis of sound curriculum that will aid children's understanding of ecological practice as an achievable goal, as well as support future developments.

In my work at Lesley University, I teach teachers about the benefits of an integrated curriculum. The Audubon Expedition Institute is the newest addition to Lesley University's Graduate School of Education. Educational institutions, like Lesley University, are looking at the fruitful relationship between environmental education, leadership and advocacy. The Bowen Initiative teaches children that new ideas that grow from the bottom up are worthwhile ventures and that dreams can indeed become actualized.

Finally, I can vouch for the follow through of the Bowen School Community.
