
"The Heart of the Highlands"

To the Members of the Community Preservation Committee,

The Brigham Community House is an invaluable community resource that provides services to some of our City's residents who need them most. I firmly believe the CPA request for a renovation to the Brigham House falls within the letter and spirit for which the CPA is intended. I urge the committee to approve these much needed funds for this worthy facility.

The Brigham Community House, houses some of the City's most important and effective programs in Newton. While the Brigham House is widely known for its teen program, which reaches 150 teens every week, they offer important programs as well. For example, the Brigham House hosts Girl Scout troop meetings, offers free computer help for seniors, houses an adult alcohol abuse prevention program and a domestic violence women's support group, and is home to a teen sewing program sponsored by the Newton Highlands Congregational Church. Just this year, *The Irving K. Zola Center for Persons with Disabilities at Brigham House* was opened. The *The Irving K. Zola Center* is a drop-in community center for persons with disabilities, and it is the only one of its kind in the state of Massachusetts.

Funding the Brigham House with CPA funds is sensible and appropriate. The facility was constructed in the 1850's, and is in need of interior and exterior repairs to maintain the Brigham House's ability to serve our community. Located at 20 Hartford Street in the center of Newton Highlands, the building is recognized as a historic structure. Funding the exterior work would preserve the functionality of an important historic structure in the heart of one of our village squares. Funding the interior work would ensure that the century-and-a-half old facility retains its functionality.

Among the criteria for allocating CPA funds is to provide recreation facilities for our citizens. The Brigham Community House does just that. Its extremely successful teen program affords our City's youth with a safe and relaxed atmosphere to gather and become involved in our community. Likewise, *The Irving K. Zola Center* creates an environment for persons with disabilities to meet, hold conversations, use computers, watch television or just relax for a few hours each week.

The Brigham Community House is an important resource that is in need of repair. This request meets the CPA funding requirements, and represents an important opportunity for us to restore and enhance the only recreational facility for our City's youth in the central and southern side of Newton. With innovative programs and a dedicated staff, the Brigham House has touched the lives of countless Newton residents, and I am grateful to Dr. Robert Staulo and the Brigham House staff for all they do for our community. I sincerely hope the CPC will fully fund this important proposal.
