Dear Chairman Grissom:

I am writing to support the granting of CPA funds to create a digital library of the plans and documents of the City of Newton Engineering Department. I believe this is critical to the present and future of the City of Newton as plans and documents fade, become lost or otherwise damaged, and the indexing and general ability to easily locate them deteriorates. These plans, notes and documents are essential parts of the City's history, but even more importantly form a critical part of working information for this and future generations.

In 1971, fresh out of Boston University School of Law, I joined the City Solicitor's office, and later remained deeply involved with the City as both a member of various committees and citizen task forces, and also as a member of the private land use bar. Institutional memory within the City consisted of quite a few employees with deeply rooted knowledge of the City's infrastructure, history and layout. They knew what were the plans (mostly linen with an increasing number of mylar type) and notes and documents, and where they were. Those staff have turned over quite a few times since 1971, and the volume and number of these materials have increased exponentially. Many of the plans are torn, fading, or just plain lost.

The staff within the City and the citizenry in general desperately need a project to reclaim, restore, digitally preserve and organize these materials! With scanning and programs which can even restore faded plans, CPA funds can assure future generations of these essential records and the plans which reveal the fabric of Newton – both above and below the ground.
