## **BOARD RESOLUTION**

## **ADOPTING**

# **AREA COUNCIL**

March 18, 2013

Whereas: a petition signed by twenty per cent of the registered voters residing in *Newtonville* was submitted to the board of aldermen requesting the establishment of a Newtonville neighborhood service area pursuant to §9-3 of the City of Newton Charter;

Whereas: after verification of such signatures a public hearing was held by the Board of Aldermen on March 6, 2013 pursuant to §9-3 of the City of Newton Charter;

Be it resolved: That a Newtonville Neighborhood Area Council be established, as follows:

#### SECTION I.

The council shall have advisory but not substantive authority in the provision of regular services of the city government. The main function of the council is to serve as an auxiliary means of communication between all departments, agencies, boards, and commissions of the city of Newton and the residents of the area so as to advise all departments, agencies, boards, and commissions of the city of Newton about the current reactions and attitudes of the area voting members to impending neighborhood issues or actions.

#### SECTION II.

The Newtonville neighborhood service area shall be led by a council comprised of nine (9) members. The term of office for each member shall be two years, and until a successor is qualified.

#### SECTION III.

The Newtonville neighborhood service area shall represent residents who live on the list of streets and map, both *attached*.

## SECTION IV.

A. Services of the council may include communicating the needs, wants, and desires of the area in regard to city-owned land, buildings, and services to the appropriate city agencies.

- B. Other services of the council may include the responsibility to inform the area of any potential changes in the village shopping area.
- C. Other services to be provided may include the development of proposed measures for the preservation of a healthy economic center in Newtonville. These may relate to physical development and determining and communicating the commercial needs of the area residents to present and prospective merchants, after consultation with the city's planning and law departments.
- D. Other services of the council may include drawing up proposals for the development of transportation facilities based on needs demonstrated by area residents.
- E. Other services of the council may include acceptance of funds from public sources, but not including the city of Newton, and private sources, including public subscriptions; and expenditure of monies to meet overhead cost of council administration and support for neighborhood services area projects.
- F. Other services of the council may include self-help projects such as beautification, establishment and maintenance of a neighborhood community center, street fairs and festivals, cultural activities, and recreation.
- G. Other services of the council may include preparing and presenting petitions to the board of aldermen for permission to amend the services to be provided by the neighborhood area council. Such petitions must be signed by twenty per cent of the voters residing in that area and shall specify the services to be provided. Upon receipt of the petitions and after verification of signatures, the board of aldermen shall, within thirty days, hold a public hearing. The hearing may be adjourned from time to time but shall be completed within sixty days. Following the public hearing, the board of aldermen by resolution shall approve or disapprove the amendment of services to be provided.

#### SECTION V.

- A. The council shall draft by-laws, a copy of which shall be filed with the city clerk..
- B. All meetings of the council shall be subject to the provisions of the open meeting law.
- C. The council shall make an annual report of its activities to the board of aldermen, which report shall be open to the public.
- D. The council shall keep complete financial records which shall be subject to city audit.




