#03-18 Simon French, 47 Glen Avenue Newton, Massachusetts, pursuant to M.G.L. c. 40A, § 8, and 15, appealing the February 26, 2018 issuance of a building permit by the Commissioner of Inspectional Services for construction of a two-family dwelling at 738 Watertown Street, Newton, Massachusetts. The appellant contends that the building permit was improperly issued because the proposed dwelling will exceed the maximum floor area ratio (FAR) allowed under applicable provisions of the Newton Zoning Ordinance. The subject property consists of a 11,250 foot lot in a Multi Residence (MR-1) district.
