1. Approval of Minutes from the July 18, 2013 ASBC+DRC Joint Meeting

Approval of Minutes from the December 12, 2013 ASBC+DRC Joint Meeting

MOTION: E. Prenner moved, seconded by S. Siegel, that the December 12, 2013 meeting minutes be approved. **The vote was unanimous.**

2. 100% Design Development Update

Joslin Lesser provided an overview of the Total Project Budget and the Design Development cost reconciliation process. It was noted that as part of reconciliation, value engineering opportunities were identified by the project team (JLA, DDP and NPB). It was noted the final value engineering items do not change or have any affect the education program, efficiency, durability or functionality of the building. The final list was reviewed with, and vetted by, Newton Public Buildings, Mayor’s Office, Newton Public Schools, Angier ES Working Group, Design Review Committee, School Committee and the Board of Alderman. Newton Public Schools feels that the functionality of the school was not compromised in any way and that the Educational program was honored and maintained. The total cost/SF was maintained below \$350/SF. It was also noted that the estimate of record is the W.T. Rich estimate, whereas this is the estimate that construction will be managed to.

3. ASBC Vote to Approve to Submit 100% Design Development Package and Budget to the MSBA

MOTION: S. Siegel moved, seconded by R. Fuller, to vote to approve to submit the 100% Design Development package to the MSBA. **The vote was unanimous.**

4. Other Business

The DRC mentioned design items noted at previous DRC meetings need to be addressed, with regard to energy, stairs, finishes, etc., and incorporated into the Construction Documents.

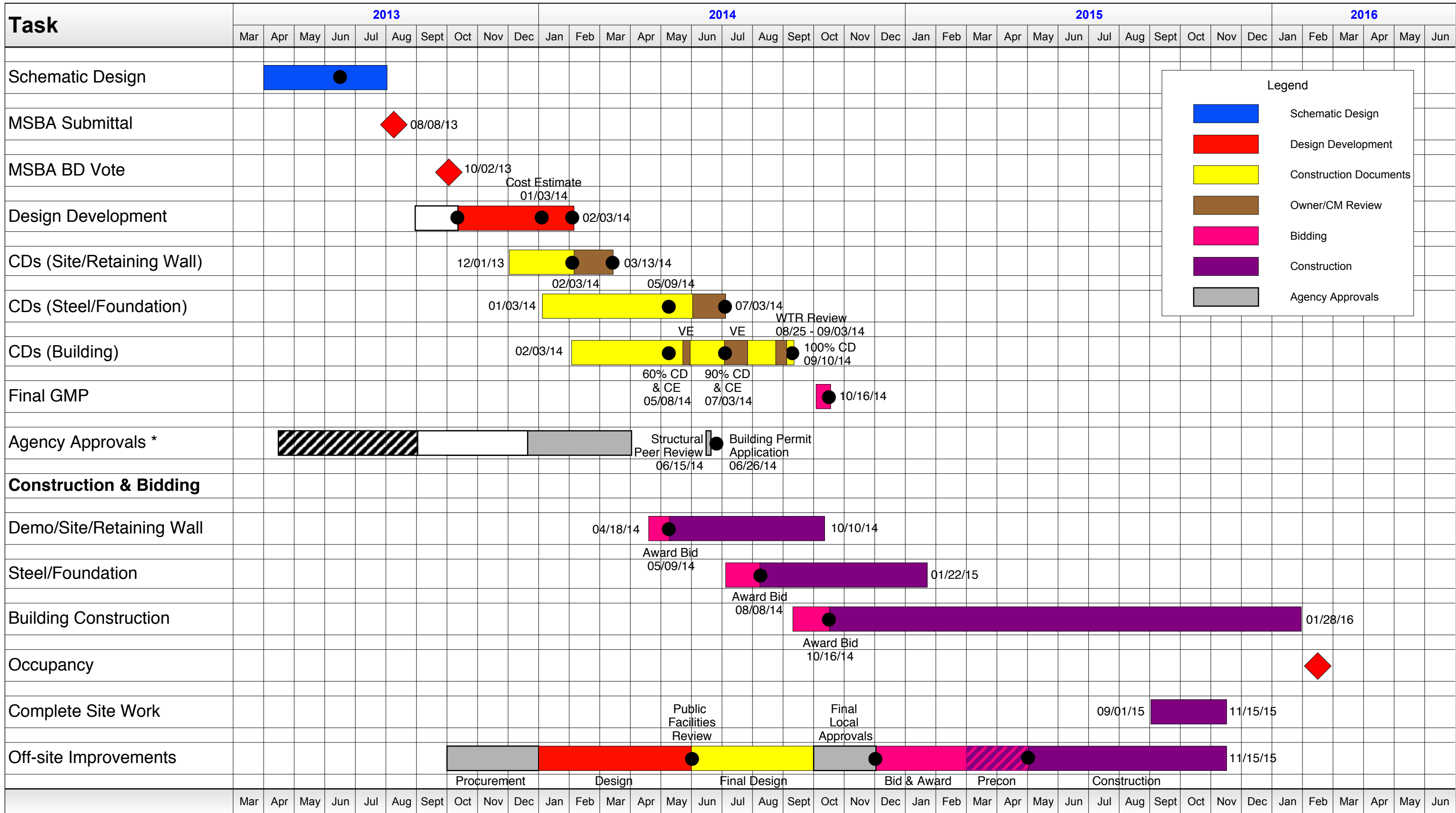
6. Adjournment

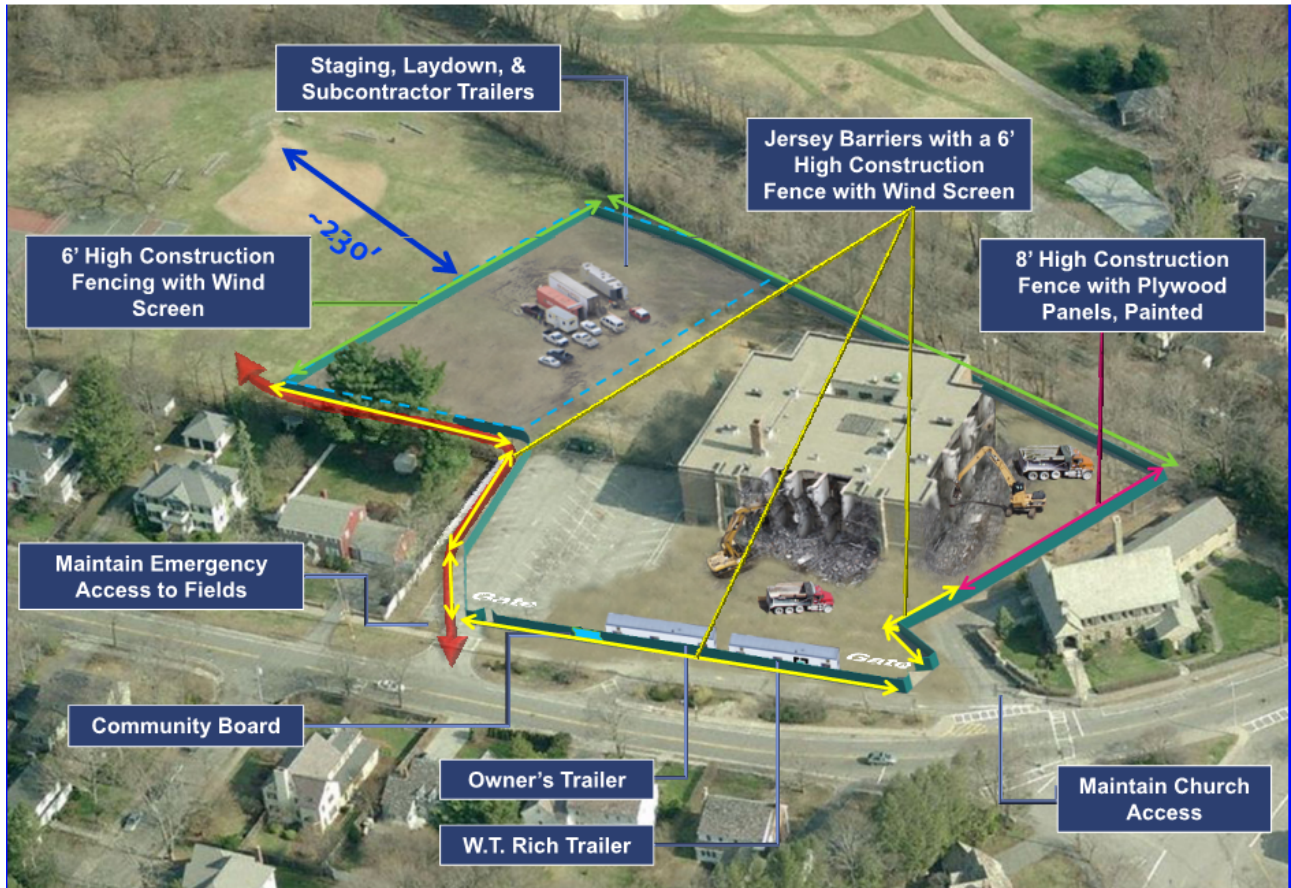

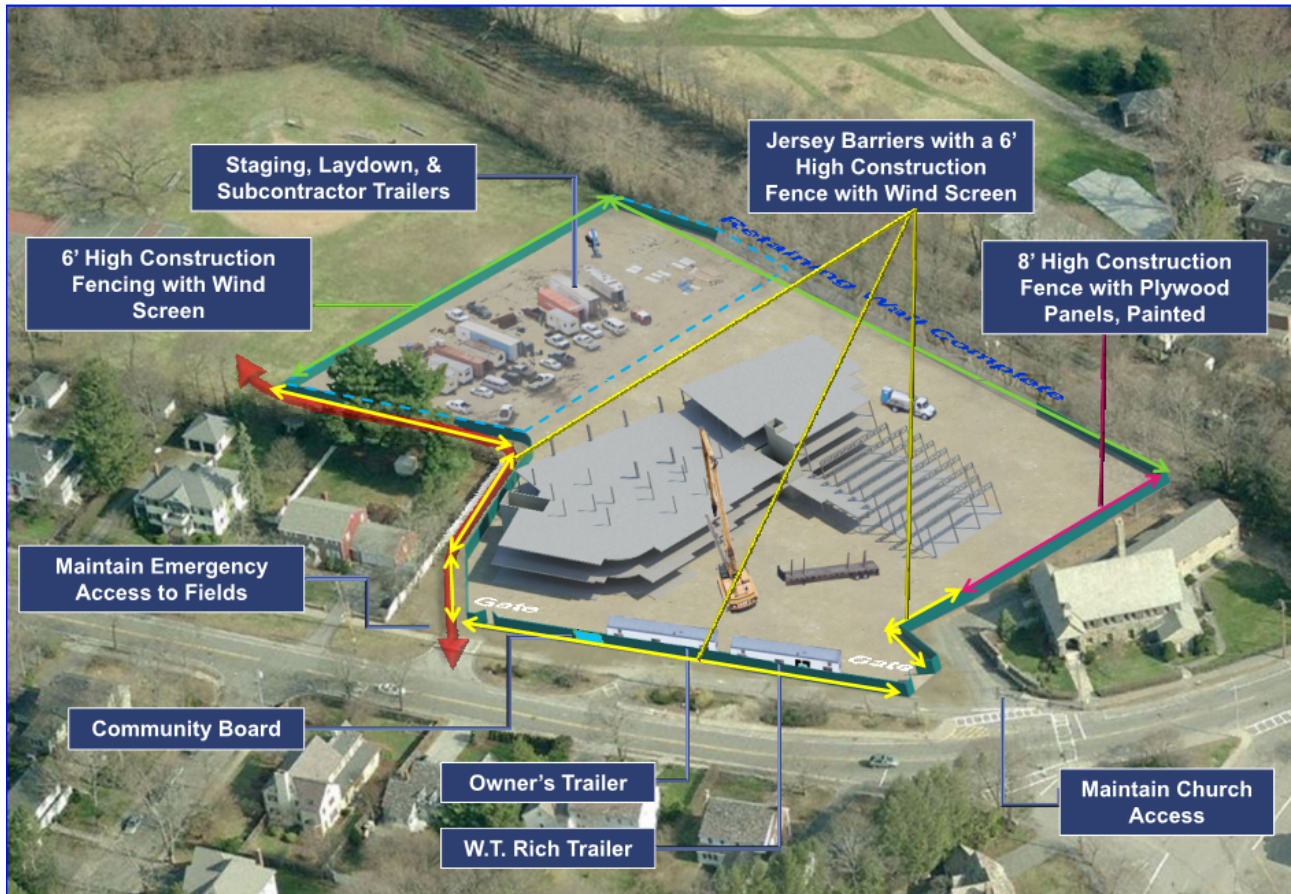

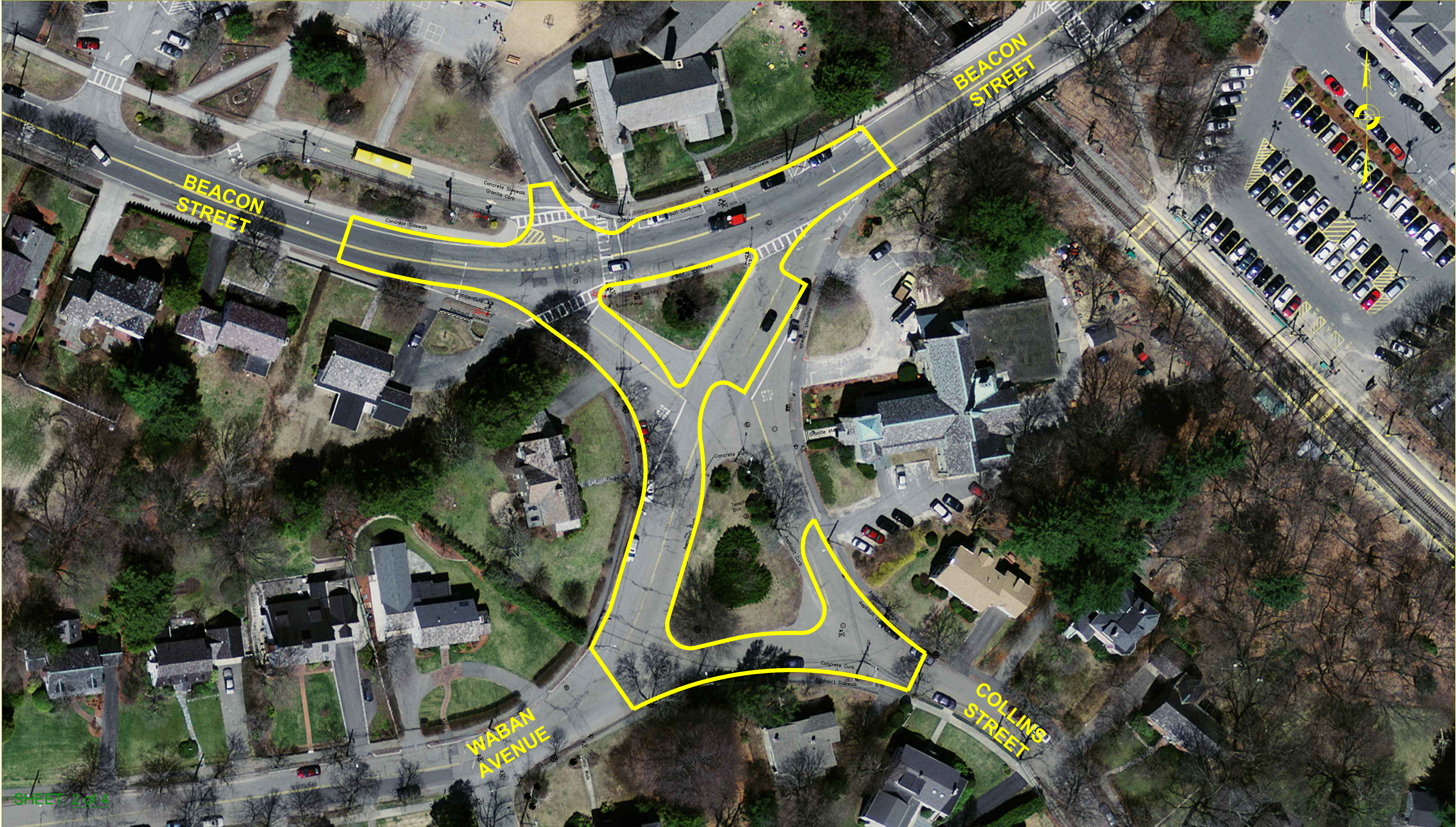
