MEDICATION DISPOSAL

Prescription and over the counter medications are accepted at the kiosk in the Newton Police Department at 1321 Washington Street.



Some products, which have been considered hazardous in the past, can now be disposed of with regular trash:

- Alkaline batteries (AAA, AA, C, D, 9-volt)
- Smoke detectors
- Latex paint (must be dried out)
- Soiled bandages (place in a sealed plastic bag)
- Driveway sealer (seal container tightly)

ITEMS ACCEPTED YEAR ROUND AT THE RESOURCE RECOVERY CENTER

- Rechargeable batteries (nickel cadmium, nickel metal hydride)
- Lithium batteries
- Automotive batteries
- Items containing mercury (fluorescent bulbs, old thermostats, thermometers)
- Propane tanks & fire extinguishers
- Motor oil, filters, antifreeze
- Medical sharps and syringes

Common Household Chemicals

Cleaners, aerosols, solvents, pest control, floor & furniture polishes, disinfectants, houseplant chemicals, spot remover, silver & copper polish



Outdoor Products

Pesticides, herbicides. fungicides, fertilizers, pool chemicals, rodent killers



Auto Products

Gasoline (we can empty your container), waxes, polishes



Flammable Paint **Products**

Oil & lead based paints (not latex), stain, varnish, thinners, adhesives



Miscellaneous

Nail polish & remover, adhesives, mothballs, artist & hobby supplies, photo chemicals, chemistry sets, flea collars, shampoos

SAFE TRANSPORT OF HHW

- Leave materials in original container
- Tighten caps and lids, seal bags
- Keep chemicals separate
- Pack in sturdy upright boxes and pad with newspaper
- Do not smoke while handling hazardous materials
- Keep materials away from children, pets, and other passengers

Managing Hazardous Products

- Minimize the use of hazardous products
- Look for alternates
- Read labels carefully
- Use according to directions
- Store products safely
