# AMENDMENT #1 GRANT AGREEMENT FOR ACQUISITION OF PROPERTY BEHIND FORMER ST. JEAN'S CHURCH

This AMENDMENT made as of August 22, 2001 by and between CASCAP, Inc., a non-profit organization having a usual place of business located at 678 Massachusetts Avenue, Cambridge, MA 02139 (hereinafter "CASCAP" or the "Grantee") and the City of Newton, a corporation organized and existing under the laws of the Commonwealth of Massachusetts, acting by and through its Director of Planning and Development or his designated staff, but without personal liability to him, (hereinafter the "City"), collectively, the "parties".

#### Witnesseth:

- 1) Attachment A. Attachment A: Scope of Services, is changed by deleting the existing and inserting the attached Attachment A: Scope of Services (Amendment 1) in its place.
- 2) Attachment B. Attachment B: Compensation & Budget is changed by deleting paragraph 1 Project Budget and replacing it with the following:
  - 1. Project Budget (Amendment 1)

The CITY hereby agrees to provide Community Development Block Grant funds to the GRANTEE in the amount of eight hundred thousand dollars (\$800,000) in the form of a grant, said amount to be subject to the terms of this Agreement.

3) All other provisions of said Agreement not amended remain in full force.

# ATTACHMENT A SCOPE OF SERVICES (Amendment 1)

#### 1. General

The Contractor shall use funds from this agreement to acquire approximately 33,000 square feet of land behind the former St. Jean's Church on Watertown Street in Nonantum for the purpose of developing 35 units of elder housing utilizing HUD Section 202 funds. This grant is conditioned upon the Grantee's acceptance of the following conditions:

- 1. The Grantee shall use the Grant funds to purchase the property at the rear of 245 Watertown Street of approximately 33,000 square feet (the "Property"). If the Grantee is unable to secure site control on or before January 1, 2002, the Grant shall be canceled.
- 2. The Grantee shall apply for funding in the 2000 funding round from the U.S Department of Housing and Urban Development for a Section 202 elderly housing development.
- 3. In the event the Grantee is not successful in obtaining HUD 202 funding in the year 2000, or is for any reason at any time during the project unable to continue on the project to bring it to completion, the Grantee shall promptly assign its interest in the Property to the City of Newton or its designee.
- 4. From HUD 202 Fund Reservation until Initial Occupancy of the completed development, CASCAP, Inc. shall be the sole sponsor of the project and shall retain control of the development process.
- 5. CASCAP, Inc. shall be entitled to a reasonable developer fee to be paid solely from the proceeds of the development and consistent with state and federal standards for developer fee.
- 6. The Grantee shall appoint an advisory committee consisting of Newton residents acceptable to the City to offer advice to CASCAP in developing elderly housing on the Property.
- 7. The Grantee shall convey control of the entity that owns the Property to the advisory committee upon initial occupancy of the completed development.
- 8. Purchase and sale and closing documents shall be submitted to the City for review and approval prior to their execution.

That the Corporation approves of the acquisition of the vacant parcel of land containing approximately 30,500 square feet located in the rear of 243-245 Watertown Street, Newton, MA, all upon the terms and conditions of a Purchase and Sale Agreement between the Corporation and the Roman Catholic Archbishop of Boston, a corporation sole (the "Archdiocese") dated May 17, 2000 as amended by amendments dated May 18, 2000, December 29, 2000 and September 24, 2001.

VOTED:

That the Corporation approves of the acceptance of a grant of up to \$800,000.00 from the City of Newton, MA upon the terms and conditions of the City's commitment letter to the Corporation as amended, a copy of which is on file with the records of the Corporation, all to meet the acquisition price of the land referred to in the foregoing vote.

VOTED:

That any of the following officers, to wit, Thomas Sadtler, President; Patricia Giulino, Vice President; Hilma Unterberger, Vice President; Douglas Muir, Treasurer; or Michael Haran, Executive Director, be and hereby are authorized and directed in the name and on behalf of the Corporation, under its corporate seal affixed if requested or required, (a) to sign, seal, execute, acknowledge and deliver loan documents, and such other or like instruments, documents, notices and certifications in connection with, arising out of, in confirmation of or in furtherance of the transactions authorized by the foregoing votes, all in such form and containing such terms, provisions and conditions as may be necessary and proper to effectuate the purchase, financing and development of the land referred to in the foregoing votes; (b) to sign, acknowledge and deliver such documents and/or certificates as may be necessary to complete the purchase, financing and development of the foregoing premises.

That the foregoing persons be and they are hereby authorized and directed in the name and on behalf of the Corporation to sign, seal and deliver such other contracts, agreements, applications and other instruments of every nature, which may be necessary or proper to consummate the transactions authorized by the foregoing votes.

That the signature of any of the foregoing persons shall be conclusive evidence of the approval of the form, of all of the terms, provisions, conditions and of the signing, execution, ensealing and delivery thereof for, in the name of, and on behalf of the Corporation.
