



## ABOUT CAN-DO

CAN-DO, Citizens for Affordable Housing in Newton Development Organization, Inc., is a community-based nonprofit developer of affordable housing for individuals and families with low and moderate incomes.

Founded in 1994, CAN-DO has developed and currently manages a number of affordable housing units serving a diverse population. Of the 36 units created to date, 30 are deed-restricted permanent affordable housing.

CAN-DO projects under management offer transitional rental housing for homeless survivors of domestic violence and for homeless single-parent families, and provide permanent rental housing for adults with developmental disabilities and low-income families.

In addition, the organization has created 15 first-time homebuyer and market-rate home ownership opportunities in the community.



Projects now in the planning stage include renovation of a two-family-residence to provide permanent rental housing for homeless veteran families.

Funding for CAN-DO projects comes from public and private sources. Public sources include federal, state, and Community Preservation Act funds. Private sources include financial institutions and private foundations. Operating costs are supplemented by the organization's public fundraising efforts in the community.
