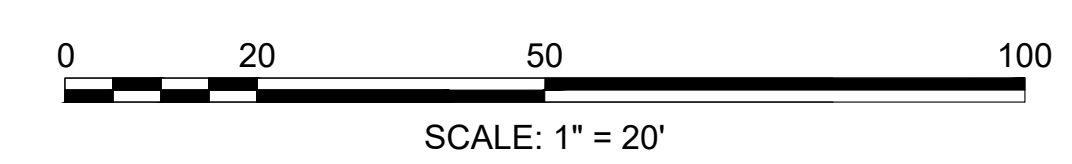

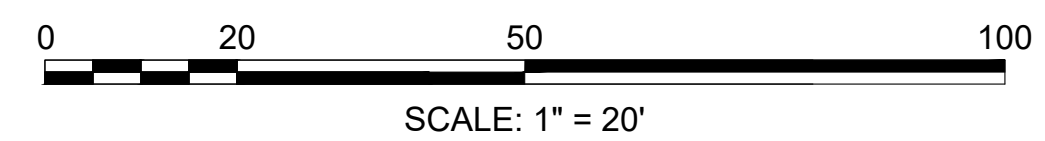
NOTE: EXAMPLE OF SHARED USE PATH TRANSITIONING TO CARRIAGE WAY ROADWAY

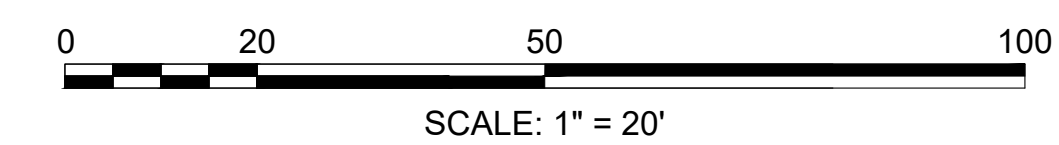

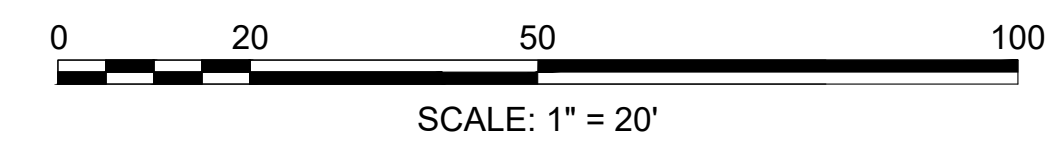




NOTE: EXAMPLE OF SIGNALIZED INTERSECTION WITH MEDIAN SEPARATED CARRIAGE WAY

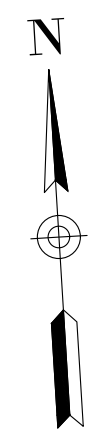
