RE: Annual Internal Affairs Analysis

January 2, 2020

Sir,

During the calendar year 2019 there were 40 Use of Force reports filed in 17 separate incidents. Of these reports 13 involved officers drawing a firearm, 2 of which was a less-than-lethal shotgun, 21 involved officers using compliance techniques, 1 officer using a baton strike along with OC spray, and 2involving officers using OC spray in the form of a compliance technique.

A review and analysis of each incident report indicates the proper level of force was used in each case and no deaths or serious injuries resulted. Although officers did draw a firearm in six incidents, none involved the discharge of a firearm. The two incidents involving a less-than-lethal shotgun were for a suicidal person who was transported to the hospital for evaluation after being shot by the less-than-lethal shotgun.

Our review and analysis of the Use of Force reports do not reveal any patterns or trends which would indicate a need for additional training or policy modification.

During calendar year 2019 there were a total of 8 citizen complaints investigated by the Newton Police. One of the complainants was anonymous, one of the complaints was not sustained, five complaints resulted in the involved officer(s) being exonerated, and two complaints were withdrawn. The seven complaints were investigated by Internal Affairs.

During calendar year 2019 there were no complaints which required an extension to the 30-day period for completing investigations.

A guide to making complaints and inquiries is available on the Newton Police website as is information on requesting annual statistical summaries. During calendar year 2019 there were no requests for annual summaries of cases investigated by the Internal Affairs Bureau.

The Internal Affairs Bureau conducted twelve internal investigations in addition to the civilian complaints. One investigation resulted in a 3-day suspension, one resulted in a 2-day suspension and one resulted in a 1-day suspension. Three investigations resulted in a letter of reprimand. Two of the reprimands involved sworn police officers and one involved civilian employees. Four of the internal affairs investigations were initiated by a supervisor. Two of the IA investigations involved insubordination. Two sworn officers had there probationary period extended. One sworn Officer was assigned to remedial training in the form of further DT instruction. No employees were terminated during calendar year 2019. During the calendar year of 2019 no discipline was related to details. Counseling was not used as a function of discipline during 2019.

During the course of these investigations no employees were subject to photographs, medical or laboratory examinations, polygraph tests, line-ups or were required to submit financial disclosure statements. One employee was placed on administrative leave while investigations were being conducted.

During calendar year 2019 there were no reported incidents where Newton Police Officers engaged in a motor vehicle pursuit. There were no reported incidents that involved warning shots.
