TRAFFIC COUNCIL REPORT

THURSDAY, MAY 7, 2020

Remote Participation:

Mr. Prizant provided a PowerPoint presentation, attached to this report.

TC16-20 COUNCILORS BOWMAN, DANBERG AND NOEL, requesting to approve stop signs on the Pleasant Street southbound and westbound approaches at Lake Avenue to create an all-way stop. (Ward 6) [03/03/20 @ 3:24 PM]

ACTION: **APPROVED 5-0. Approved the language of TPR 623.**
This item may be appealed through the close of business May 27, 2020.

NOTE: Council members were provided with a location map, site photos, vehicular, pedestrian and bicycle volumes, Manual on Traffic Control Devices (MUTCD) guidance and language for consideration.

Mr. Prizant stated that there is a stop sign and stop bar located on Pleasant Street at Lake Avenue, looking north from Lake Avenue. On Pleasant Street looking west at Lake Avenue there is no yield or stop sign.

Mr. Prizant stated that vehicular, pedestrian and bicycle volumes were collected on February 25, 2020 at morning and afternoon school peak times to collect data on how to address issues and how the intersection is operating. The MUTCD provides guidance with warrants on when to install stop signs. Criteria A, B, C, D, E and H were not met. Criteria F and G were met. There has been one reported crash in the past three years. Mr. Prizant then stated that he recommends an all-way stop at Pleasant Street at Lake Avenue, southbound and westbound.

Mr. Koses opened the discussion to members of the public who were present. Residents expressed their concerns and suggestions.

Concerns:

- If this stop sign is approved, vehicles will stop and go making pollution.
- Vehicles do not slow down or stop when approaching Lake Avenue.
- Vehicles have the tendency to speed on Lake Avenue.

Suggestions:

- Please install a pedestrian activated flashing yellow light making drivers aware of pedestrians.

Residents present stated that they support an all-way stop sign at this location as Mr. Prizant recommends due to the warrants being met.

Mr. Prizant stated that Traffic Council cannot approve the suggestion of installing a pedestrian activated light because the suggestion is not part of this docket item. Pedestrian activated lights are expensive. He then said that he will evaluate the situation further.

Councilor Bowman stated although the pedestrian activated light is expensive it may be a good solution in this area. It would be necessary to install a post to install the light on. She is hopeful the stop sign will make drivers aware and pull back their speeds making the intersection safe. She then stated that Safe Routes to School, Mason-Rice Elementary School principal and vice principal support this docket item.

Without further discussion, Mr. Koses made a motion to approve this request. Council members agreed 5-0. Mr. Koses stated that this item may be appealed through the close of business May 27, 2020.

TC15-20 COUNCILORS BOWMAN, DANBERG AND NOEL, requesting to prohibit parking all days and all times on the east side of Pleasant Street, beginning at the intersection with Lake Avenue heading northerly 85 feet, to provide for safe maneuverability around the Pleasant Street and Lake Avenue intersection. (Ward 6) [03/03/20 @ 3:24 PM]

ACTION: **APPROVED 5-0. Approved the language of TPR 624**
This item may be appealed through the close of business May 27, 2020.

NOTE: Council members were provided with a location map, site photos and language for consideration.

Mr. Prizant stated that this docket language is to avoid a head-on collision when driving past parked vehicles at the curve on Lake Avenue. Two parking spaces would be removed if the 85-foot parking prohibition is approved.

Mr. Koses opened the discussion to members of the public. Residents present expressed their concerns and suggestions.

Concerns:

- When vehicles park at the curve, Pleasant Street becomes a one-way because it is difficult to pass parked vehicles.
- Drivers have the tendency to ignore the parking prohibitions on Pleasant Street.

Suggestions:

- A suggestion was made to extend the parking prohibition to the crosswalk at Pleasant Street.

Residents present stated that they support this parking prohibition to provide for safe maneuverability around the Pleasant Street and Lake Avenue intersection.

Mr. Koses answered that administratively the Department Public Works can restrict parking up to 50 feet of an intersection.

Without further discussion, Mr. Koses made a motion to approve this request. Council members agreed 5-0. Mr. Koses stated that this item may be appealed through the close of business May 27, 2020.

TC14-20 COUNCILORS BOWMAN, DANBERG AND NOEL, requesting to extend the blue zone on the east side of Pleasant Street to a point 20 feet north of Tyler Terrace. (Ward 6) [03/03/20 @ 3:24 PM]

ACTION: **APPROVED 5-0. Approved the language of TPR 625.**
This item may be appealed through the close of business May 27, 2020.

NOTE: Council members were provided with a location map and site photos.

Mr. Prizant stated that this docket item requests extending the blue zone on Pleasant Street towards Tyler Terrace (towards the telephone pole).

Councilor Downs asked if vehicles are parking in front of the telephone pole at the bend of the road at Tyler Terrace? Mr. Prizant answered that City Ordinance prohibits parking within 20 feet of an intersection.

Captain Anastasia suggested extending the blue zone to the telephone pole and suggested posting a 'no parking' sign on the telephone pole to deter vehicles parking in that one parking space. Mr. Koses stated that the traffic superintendent would decide if signs will be posted on the existing telephone pole or a new post.

Councilor Bowman suggested painting road hatch markings where parking is prohibited.

Mr. Prizant stated that administratively the Department Public Works can restrict parking up to 50 feet of an intersection.

Mr. Koses opened the discussion to members of the public. A resident stated that police enforcement is necessary. Mason-Rice Elementary School Principal, Jacob Bultema stated that safety is necessary and appreciates Traffic Council's effort in making the location safe.

Captain Anastasia stated that parking control officers also have the roles of crossing guards.

Without further discussion, Mr. Koses made a motion to approve this request. Council members agreed 5-0. Mr. Koses stated that this item may be appealed through the close of business May 27, 2020.

TC10-20 WILLIAM LAMB, 80 Paul Street, requesting removal of the “No Parking” sign (in the direction towards Parsons Street) in front of 1069 Washington Street. (Ward 3) [01/29/20 @ 12:20 PM]

ACTION: APPROVED 4-1 (Councilor Downs opposed). Approved the language of TPR 626.

This item may be appealed through the close of business May 27, 2020.

NOTE: Mr. Lamb, petitioner joined the Council for discussion on this item.

Council members were provided with a location map, site photos and options for consideration.

Mr. Prizant stated that there is a parking prohibition of no parking, anytime from a point 88 feet west of Parsons Street and recommends a parking prohibition of no parking, anytime from a point 35 feet west of Parsons Street to a point 100 feet east of Cross Street, north side. The proposed parking prohibition maintains safe visibility for turning vehicles. This section of Washington Street would have the following: No parking, anytime, no parking restriction (parking for one vehicle) and no parking anytime.

Mr. Lamb stated that he owns the building at 1075 Washington Street. His Traffic Council petition states that “this request is to remove a sign in front of 1069 Washington Street that says no parking (with an arrow pointing toward Parsons Street). This sign is not needed because another no parking sign already keeps parking 37 feet back from Parsons Street. Making this change will create 32 feet of much-needed on-street parking spaces on the north side of Washington Street”. He then stated that twelve people signed the Traffic Council petition. Parking is necessary for the businesses. Parking balance and safety are necessary. Mr. Lamb then stated that he is opposed to the suggestion of no parking, anytime. He suggested posting a sign no parking within 5 feet of the driveway.

Councilor Bowman asked what type of driveway is located at 1075 Washington Street. Mr. Lamb answered that it is a dead-end driveway. Councilor Bowman then stated that drivers need more than 5 feet clearance when exiting the driveway to observe parked vehicles. Site lines are necessary.

Councilor Kelley suggested extending the no parking restriction further in the westerly direction to allow better site visibility. To allow parking for one vehicle is not a safe situation.

Councilor Downs stated that site visibility is difficult near the driveway making entering and exiting the driveway difficult and drivers have the tendency to speed.

Mr. Koses opened the discussion to members of the public who were present. Business owners expressed their concerns.

Concerns:

A nearby business owner stated that it is preferable to maintain the current parking restrictions on Washington Street. Pedestrian, visitor and student safety are necessary.

Mr. Lamb stated that the neighbors complain when commercial tenants park on Parsons Street. Neighbors would prefer to maximize parking on Washington Street.

Unfortunately, the two business owners disagree on this item.

Councilor Bowman stated that she is concerned with allowing parking for one vehicle. One parked vehicle may lead to two or three vehicles parking at the corner of Washington Street and Parsons Street. Visibility is necessary for pedestrians and bicyclists safety. Site visibility is difficult in this area. She then asked Mr. Prizant if he was concerned regarding site line visibility if one, two or three cars parked in the suggested one parking space.

Mr. Prizant stated that it was Mr. Lamb's right to docket this request to introduce parking options for consideration. He then stated that he has not heard negative feedback from Parsons Street residents.

Mr. Koses stated that parking remains available on Parsons Street. He then stated that City Ordinance requires no parking within 5 feet of a driveway. If this item is approved, it can be modified in the future or appealed. He then asked Mr. Prizant if it is necessary to install no parking signs within 5 feet of the driveway. Mr. Prizant answered we should start without posting a no parking within 5 feet of a driveway and if it becomes necessary to post, the Department Public Works may post this sign administratively.

Mr. Prizant again stated that he recommends a parking prohibition of no parking, anytime from a point 35 feet west of Parsons Street to a point 100 feet east of Cross Street, north side. Mr. Prizant feels that allowing one parking space will work. If the one parking space becomes an issue or safety concern, pavement markings could be painted along with deploying police enforcement.

Councilor Downs asked Captain Anastasia if he would approve parking for one vehicle. Captain Anastasia answered that he did not have a concern with adding one parking space. He does not see this as a safety issue. He then stated that he is concerned with vehicles parking within 5 feet of the driveway.

Without further discussion, Captain Anastasia made a motion to approve this request (creating one parking space on Washington Street as the PowerPoint shows). Council members agreed 5-0. Mr. Koses stated that this item may be appealed through the close of business on May 27, 2020.

Mr. Koses stated that the below sixteen items either fix errors or omissions in the Traffic and Parking Regulations (TPR).

Phillips Street, from Commonwealth Avenue southeasterly to Bourne Street.

By INSERTING into the provisions of **Sec. TPR-85. One-way streets.**, the following:

Phillips Street, from Bourne Street to Commonwealth Avenue.
