It is not safe when vehicles park at the curve and they have the tendency to park on the berm or sidewalk. It is difficult to exit the driveway of 1159 Chestnut Street when vehicles park close or opposite the driveway. It is difficult to see bicyclists and pedestrians when vehicles park so close to the driveway. The residents stated that they support this docket request.

Councilor Humphrey stated that he briefly discussed this docket request with the Newton Upper Falls Area Council who expressed no concerns on approving this request.

Mr. Koses asked the residents of 1159 Chestnut Street if the utility pole between 1159 Chestnut Street and the Bobby Braceland park was working. The resident said that the light is not working and has reported this problem to the City on two occasions. They then added that the light in the Tot Lot is not working. Mr. Koses then asked if the utility pole at the tower (not City property) is working. The resident answered years ago, the City replaced the light bulb. Mr. Koses asked if the light bulb was replaced prior to the "No Trespassing" signs being posted. The resident was not sure. Mr. Koses said that unfortunately, this is not City property and the Department Public Works cannot fix this light. Mr. Koses stated that he would discuss this light issue with the Parks and Recreation Department because the light is on their property.
