# Mayor's Update

#### **COVID-19 Update and Losses**


There are 789 confirmed cases of COVID-19 among Newton residents, according to preliminary data through July 21, 2020, an increase of 13 new cases since a week ago, July 14. While this is a bigger increase than we have experienced lately, the timing of when we receive the data is variable and therefore not always indicative of changes in community transmission rates.

Please know that our public health staff are looking at our positive cases closely to monitor for any trends that could affect community transmission.

Approximately 82 percent of Newton confirmed cases (excluding people in long-term/assisted living facilities) have met the criteria to discontinue isolation (and are considered recovered). This is up from approximately 78 percent in late June and is stable from last week when we reported 83 percent.

With sadness, I also have to report that we received notification that three more Newton residents have died after testing positive for COVID-19, bringing our total losses to 122. These residents were often mothers and fathers, sisters and brothers, aunts and uncles, friends and neighbors. They were loved and are missed, and a grim reminder that this crisis is not over. How can we help those who are grieving? Wear face coverings inside and out when we can't physically distance, wash our hands and stay home if not feeling well.

#### More on Reopening Schools

Plans for opening the Newton Public Schools in September are well underway. As required by the state, NPS is developing three models: all in-person with safety protocols in place, a hybrid model (each student at school on some days and learning remotely on others) and full distance learning.

Importantly, the Newton Health and Human Services staff have recommended that 6 feet of distance be maintained in our schools between people when they are stationary for more than 10 minutes. As a result, fewer people can be in our classrooms at one time. This means the return to school of all students at the same time in September is all but impossible.

In person classes, even with fewer people in classrooms in the hybrid model, will involve required health and safety protocols and procedures. These will include physical distancing, face coverings, hand hygiene and cleaning, and avoiding exposure to illness (i.e., staying home if sick and testing).

Right now, an outline of some type of hybrid model with students attending school both in-person and online each week is coming into focus as the administrators, teachers and staff work to provide academic engagement and equity while keeping health and safety (both physical and social/emotional health) of students and educators at the forefront of the planning. NPS expects the plan for the start of school to be finalized over the next two weeks. Several critical pieces are still being worked out (e.g., bus transportation).

NPS is holding Zoom chat sessions with families tomorrow, Thursday, July 23 and Friday, July 24. The sessions will be conducted by grade level. These sessions will include initial feedback from the family survey, a review of the planning process, and a timeline for decision-making. 
Overdue: Confronting Race & Racism in Newton: A Virtual Conversation with Prof. Ibram X. Kendi

## **Conserving Energy and Going Green**

Hot weather means high electricity use. During peak demand periods, older, less efficient generation plants, which are more polluting, are brought on line. Mid-afternoon to early evening are typically the times of particularly heavy

demand on the electric power grid in heat waves.

We don't expect any disruption in Newton's electricity supply, but all of us can help New England reduce electricity demand, greenhouse gas emissions, and other pollutants by:

- Setting air conditioners at as high a temperature as you comfortably can (e.g., 74-76<sup>o</sup> F).
- Limiting the use of air conditioning if possible in rooms that are infrequently used.
- Making sure windows and doors in air conditioned spaces are closed when air conditioners are operating.
- Using ceiling fans if you have them.
- Closing shades or drapes where the sun is shining in.
- Shutting off lights that are not essential.
- Removing or unplugging unused appliances.

You can also opt up to 100% renewables as part of Newton Power Choice. As you may recall, in March 2019, the City of Newton started Newton Power Choice and switched the supply of the City's electricity customers that had Eversource basic service to 60 percent renewable sources such as solar and wind, significantly reducing the City's carbon footprint.

What exactly are the electric resources that are in Newton Power Choice and New England's electricity grid? Click <u>here</u> to see the Newton Power Choice and the region's fuel mix for the second quarter of 2020. For that period, all Newton's renewable energy came from New England solar, wind, and small hydro resources (not Canadian hydro). Although the link shows some amount of biomass and wood as part of the region's generation mix, Newton has specifically excluded those resources from its voluntary power purchase.

## Newton COVID-19 Care Fund Raised \$670,000

The Newton COVID-19 Care Fund, established early in the COVID- 19 crisis to offer immediate financial assistance to people financially impacted by the pandemic, raised a total of \$670,000 from more than 1,000 generous donors.

Together with community leaders (especially Rob Gifford, Anne Larner, Claire Sokoloff, Gloria Gavris and Susie Heyman) and partners at the United Way Massachusetts Bay and Merrimack Valley (with special kudos to Gail Sokoloff, Sarah Link, and Connie French) and Family Access (Jon Firger and Karen Seniuk: our heroes), we helped 339 individuals and families with checks distributed for needs from \$9.00 to \$2,500.

Consistent with the group's mission as a short-term emergency fund, 441 applications were accepted through June 5, 2020. The 102 applicants who did not receive funds were either ineligible, never completed their application process or communicated that they were no longer in need of assistance.

The single most common request for funds was related to housing expenses, either rent or mortgage assistance. The second most common request was for help with utility expenses. Other expenses that were high on the list of requests included carrelated bills, health care-related bills, childcare, and funeral expenses.

Many thanks to each and every donor. The generosity of so many Newtonians helped members of our community at a very challenging, distressing time.

#### Still need help?

Applications are still being accepted for Newton's Emergency Housing Assistance Fund. Newton residents who are experiencing a reduced income as a direct result of COVID-19 and earn 80% or less of the Area Median Income (AMI) at the time their application is submitted are encouraged to apply. Income-eligible Newton households may receive up to three months of rental or mortgage assistance (mortgage assistance only available to owners of affordable deed-restricted units). The assistance has a monthly cap of \$2,500 per household, or \$7,500 per household, for three months.
