#306-20 Request for salary increase for City Clerk/Clerk of the City Council

<u>COUNCILORS ALBRIGHT AND LIPOF</u> requesting an increase in the salary of the City Clerk/Clerk of the City Council to \$143,911 effective July 1, 2020 to match the percentage increase included in the FY21 budget for H-grade employees.

#307-20 Request to move the Ward 2 Precinct 2 polling location

<u>CITY CLERK</u> requesting that the polling location for Ward 2, Precinct 2, which is currently located at the Cabot Park Village Assisted Living Facility off of Newtonville Avenue be moved back to the Cabot School on Cabot Street. The polling location was moved out of the Cabot School during the school's renovations. This move is to protect the seniors that live at Cabot Park Village from Covid-19. The Cabot School will be unoccupied by students on Election Days in 2020.

#308-20 Request to move the Ward 2 Precinct 3 polling location

<u>CITY CLERK</u> requesting that the polling location for Ward 2, Precinct 3, which is currently located at the Newton Senior Center on Walnut Street be moved down the Street to the Newton North High School. This move is to protect the seniors that use the Senior Center from Covid-19. Newton North High School will be unoccupied by students on Election Days in 2020.
