Approved, subject to the following conditions:

- 1. All buildings, parking areas, driveways, walkways, landscaping and other site features shall be located and constructed consistent with a concept plan shown in the report of the Newton Department of Planning and Development, submitted for the public hearing on June 11, 1996.
- 2. If the petitioners intend to seek permission to continue the tent sale beyond the five (5) years authorized by this Board Order, the petitioners shall conduct a parking demand survey during the summer of 2008 (not necessarily during the time of the tent sale), and such survey shall be submitted with the re-application for continued tent sales.
- 3. All conditions of previous board orders shall remain in effect except as amended by this Board Order.
- 4. This Board Order shall expire five (5) years from the date of approval.
- 5. The Fire Department approves the material and location of the tent.
- 6. The Inspectional Services Department approves the circulation within the tent.
- 7. Use of the temporary tent is allowed for not more than 15 sale days, generally between August 15th and Labor Day.
- 8. The Planning Department shall review the annual administrative application for consistency with this approved Board Order.
- 9. The tent shall be no larger than 82 ft. x 246 ft. and shall displace not more than 90 parking spaces.
- 10. The hours of use for the tent are no longer than those for the store.
- 11. No building permit shall be issued pursuant to this SPECIAL PERMIT/SITE PLAN APPROVAL and until:
 - a. The Fire Department has given its approval as required in Condition #5.

- b. The petitioner has complied with all State Building Code requirements for temporary structures.
- c. The petitioner shall have recorded with the Registry of Deeds for the Southern District of Middlesex County a Certified copy of this Board Order granting this SPECIAL PERMIT/SITE PLAN APPROVAL with appropriate reference to the book and page of the recording of the Petitioner's title deed or notice of lease endorsed thereon.
- d. A certified copy of such recorded notice shall have been filed with the City Clerk, the Inspectional Services Department and the Department of Planning and Development.
