I am a native resident of Newtonville and currently reside at 125 Edinboro Street. I can't state in simple words how much I am opposed to the project in Newtonville centered on the corner of Walnut and Washington Streets. Simply put it is nothing but an attack on the character of Newton.

I simply can't understand how a project like this got past zoning as it is unfit for any city never mind Newton. From what I have read in the Tab there will be 151 units and 91 parking spaces? Math was always my worst subject in school but even I can see that isn't right. In an area with tight parking we are expecting a minimum of 60 cars to be rolled up like newspapers at night?
