- 1. The sign and other site features associated with this special permit/site plan approval shall be located and constructed consistent with:
  - a. Sign permit site plan, stamped by Bradley J. Simonelli, dated 3/25/13
  - b. Photo of proposed sign and location, dated 6/9/13
- 2. There shall be no up-lighting of the freestanding sign.
- 3. The final location of the sign may be shifted per the direction of the City Traffic Engineer to improve traffic visibility for cars exiting the site, provided that the sign remain in the same general area as shown on the plans identified in Condition #1.
- 4. No building permit shall be issued pursuant to this SPECIAL PERMIT/SITE PLAN APPROVAL until the petitioner has:
  - a. Recorded with the Registry of Deeds for the Southern District of Middlesex County a certified copy of this Board Order granting this SPECIAL PERMIT/SITE PLAN APPROVAL.
  - b. Filed a certified copy of such recorded notices with the Clerk of the Board, the Inspectional Services Department and the Department of Planning and Development.
  - c. Obtained a written statement from the Planning Department that confirms the building permit plans are consistent with plans approved in Condition #1.
