Grant of Location Process:

- 1. Applicant submits completed Petition Form and required materials to the City Council
- 2. Public Works Department conducts preliminary review and gives written comments to the applicant
- 3. Engineering Division files Petition Form with comments with the Clerk of the City Council
- 4. City Council schedules petition for a public hearing before the Public Facilities Committee of the City Council
- 5. Public Facilities Committee recommendations are forwarded to the City Council for a final decision

Worcester Massachusetts, dated August 21, 2017 To the City of Newton, Massachusetts

VERIZON NEW ENGLAND, INC. and NSTAR ELECTRIC COMPANY d/b/a EVERSOURCE ENERGY

request permission to locate poles, wires, cables and fixtures, including the necessary anchors, guys and other such sustaining and protecting fixtures to be owned and used in common by your petitioners, along and across the following public way or ways:

<u>CARLSON AVENUE</u>: Relocate one (1) jointly owned pole numbered T.1105-1 to a point on the northwesterly side of Carlson Avenue approximately one hundred thirteen (113) feet southwesterly from the center line of Dedham Street.

<u>Reason:</u> Relocate one (1) jointly owned pole on Carlson Avenue to accommodate a road reconstruction project; and to provide for the distribution of intelligence and telecommunications and for distribution of high and low voltage electric current.


