LEGAL DESCRIPTION – PROPOSED BU4 ZONE

TWO PARCELS OF LAND LOCATED OFF NEEDHAM STREET NORTH OF OAK STREET IN THE CITY OF NEWTON, IN THE COUNTY OF MIDDLESEX AND THE COMMONWEALTH OF MASSACHUSETTS BEING SHOWN AS "PROPOSED BU4 ZONE" ON A PLAN ENTITLED "ZONE CHANGE PLAN", SHEET C-3, DATED MAY 9, 2017, BOUNDED AND DESCRIBED AS FOLLOWS:

WEST PARCEL

A CERTAIN PARCEL OF LAND, COMPRISING THREE LOTS, LOCATED NORTH OF OAK STREET AND WEST OF NEEDHAM STREET BOUNDED AND DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE NORTHERLY SIDELINE OF OAK STREET AND THE WESTERLY SIDELINE OF NEEDHAM STREET SAID POINT BEING THE SOUTHEASTERLY CORNER OF THE DESCRIBED PARCEL; THENCE

- N 74°10′56″ W A DISTANCE OF ONE HUNDRED SIXTY-SIX AND SIXTY-THREE HUNDREDTHS FEET (166.63') TO A POINT; THENCE

NORTHWESTERLY AND CURVING TO THE RIGHT ALONG THE ARC OF A CURVE HAVING A RADIUS OF FIVE HUNDRED TWENTY-ONE AND EIGHTEEN HUNDREDTHS FEET (521.18'), A LENGTH OF THREE HUNDRED SIXTY-EIGHT AND FORTY-SIX HUNDREDTHS FEET (368.46') TO A POINT, THE LAST (3) COURSES BY THE NORTHERLY SIDELINE OF OAK STREET; THENCE

A CERTAIN PARCEL OF LAND, COMPRISING TWO LOTS, LOCATED ON THE EAST SIDE OF NEEDHAM STREET AT THE INTERSECTION OF NEEDHAM STREET AND CHARLEMONT STREET, BOUNDED AND DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE EASTERLY SIDELINE OF NEEDHAM STREET AND THE SOUTHERLY SIDELINE OF CHARLEMONT STREET SAID POINT BEING THE BEGINNING OF A CURVE AND THE NORTHWESTERLY CORNER OF THE DESCRIBED PARCEL; THENCE

NORTHEASTERLY AND CURVING TO THE RIGHT ALONG THE ARC OF A CURVE HAVING A RADIUS OF TWENTY AND NO HUNDREDTHS FEET (20.00'), A LENGTH OF THIRTY-ONE AND EIGHTY-EIGHT HUNDREDTHS FEET (31.88') TO A POINT; THENCE
