# **ORDINANCE NO. A-27**

# BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF NEWTON AS FOLLOWS:

Section 30 of the Revised Ordinances of Newton, 2012, as amended, be and is hereby further amended by amending sheets of plans entitled "City of Newton, Massachusetts, Amendments to Zoning Plans, adopted July 21, 1951, as amended from time to time," by changing certain boundaries from present zoning district as described below:

Change the following described real estate now in a Public Use District to a Mixed Use 3/Transit Oriented District, identified by the City of Newton as Section 42, Block 11, Lot 3A, the parcel contains 408,466 square feet more or less and is shown on a Plan entitled "The Station at Riverside, Proposed Rezoning Plan Change" prepared by Vanasse Hangen Brustlin, Inc., dated August 28, 2012, the parcel is situated on the westerly side of Grove Street and Southerly side of the Massachusetts Bay Transportation Authority (MBTA) Greenline in the City of Newton, in the County of Middlesex and the Commonwealth of Massachusetts bounded and described below.

This Change of Zone Order accompanies Special Permit #258-12(2). The benefits of this zone change shall only vest if Special Permit #258-12(2) is approved and vested in accordance with the provisions of condition 3(a) of Special Permit #258-12(2).

- N 66<sup>°</sup> 47'52" W A DISTANCE OF FIVE HUNDRED THIRTY ONE AND SEVENTY EIGHT HUNDREDTHS FEET (531.78') TO A POINT, BY LAND NOW OR FORMERLY BH NORMANDY OWNER, LLC; THENCE
- N 11° 48'59" W A DISTANCE OF THREE HUNDRED FORTY FOUR AND NINETY THREE HUNDREDTHS FEET (344.93') TO A POINT; THENCE
- NORTHWESTERLY AND CURVING TO THE LEFT ALONG THE ARC OF A CURVE HAVING A RADIUS OF TWO THOUSAND ONE HUNDRED AND NO HUNDREDTHS FEET (2,100.00'), A LENGTH OF EIGHTY THREE AND FOUR HUNDREDTHS FEET (83.04') TO A POINT, THE LAST (2) COURSES BY THE EASTERLY SIDELINE OF ROUTE 95; THENCE
- N 75° 55'04" E A DISTANCE OF SEVENTY NINE AND THIRTY SIX HUNDREDTHS FEET (79.36') TO A POINT; THENCE
- S 62° 35'09" E A DISTANCE OF ONE HUNDRED THIRTY FIVE AND NINETY FIVE HUNDREDTHS FEET (135.95') TO A POINT; THENCE
- S 35° 37'38" E A DISTANCE OF ONE HUNDRED THIRTY SIX AND SEVENTY

# FIVE HUNDREDTHS FEET (136.75') TO A POINT; THENCE

- N 25° 09'34" E A DISTANCE OF THREE HUNDRED THIRTY ONE AND SIXTY FIVE HUNDREDTHS FEET (331.65') TO A POINT; THENCE
