EXPLANATORY REMARKS: The applicant seeks to amend Board Order #242-09 (i) to allow for expanded cooking and equipment by removing Condition #7 and (ii) to amend Condition #2 to increase the maximum number of employees at the largest shift from 9 to 12 and to increase the parking waiver (Section 5.1.4) by one stall for a total parking waiver of 15 stalls during the six-month period from November through April and a total parking waiver of 24 stalls during the six-month period from May through October.
