MINUTES OF PUBLIC MEETING AND PUBLIC HEARINGS **AUBURNDALE HISTORIC DISTRICT COMMISSION**

The meeting was called to order at 7:00 p.m. with Italo Visco presiding as Chair. Voting permanent members were D. Capasso, P. Dudek, D. Kayserman. B. Kurze acted as recording secretary and the meeting was recorded on Zoom.

59 Maple Street, Carriage House - Certificate of Appropriateness and Working Session

Ivan Hernandez presented an application to renovate the carriage house. The exterior changes would be minimal: replacing doors, skylights and windows; relocating some doors and windows, and adding a new side entry and several new windows. The brick drive and parking area would be expanded, and a brick walkway with bluestone steps would be installed. He noted that the windows would be Pella Architect Series; a sample was dropped off with I. Visco.

Commission members agreed that the changes were appropriate and sensitive to the original style of the carriage house. I. Visco said the Pella window was an appropriate style and good quality; he appreciated the care that was taken to design changes consistent with the carriage house and to use quality materials. Staff advised that the submission did not include all of the product and material information, but if members were comfortable with the design and information presented, a motion could be made to approve the project with the requirement that the complete submission be sent to Staff for review and approval by Staff and a commission architect. D. Capasso moved to grant a Certificate of Appropriateness for the application as presented with conditions for the final submission. P. Dudek seconded the motion. There was a roll call vote and the motion passed unanimously, 4-0.

The project includes replacing and removing doors and windows, installing new windows, replacing skylights, building a new side entry, expanding the driveway and parking areas, and installing a walkway.
