ORDERED:

That the City Council, finding that the public convenience and welfare will be substantially served by its action, that the use of the site will be in harmony with the conditions, safeguards and limitations set forth in the Zoning Ordinance, and that said action will be without substantial detriment to the public good, and without substantially derogating from the intent or purpose of the Zoning Ordinance, grants approval of the following SPECIAL PERMIT/SITE PLAN APPROVAL to allow a series of retaining walls exceeding four feet in height within the front and side setbacks, as recommended by the Land Use Committee for the reasons given by the Committee, through its Chairman, Councilor Richard Lipof:

- 1. The specific site is an appropriate location for the proposed system of retaining walls greater than four feet in height within the front and side setbacks due to the grade change of the site. (§7.3.3.C.1)
- 2. The proposed system of retaining walls greater than four feet in height within the front and side setbacks will not adversely affect the neighborhood because of the specific topography of the site. (§7.3.3.C.2)
- 3. The proposed series of retaining walls greater than four feet in height within the front and side setbacks will not create a nuisance or serious hazard to vehicles or pedestrians because there are no changes to the approved curb cut and driveway locations. (§7.3.3.C.3)
- 4. Access to the site over streets is appropriate for the types and numbers of vehicles involved. (§7.3.3.C.4)

- a. "Proposed retaining walls plan" showing proposed conditions at 21 Louise Road, signed and stamped by Edmond T. Spruhan, Professional Land Surveyor, dated November 23, 2020
- 2. Prior to the issuance of any building permit, the petitioner shall provide a final site plan for review and approval by the Department of Planning and Development and the Engineering Division of Public Works.
- 3. Prior to the issuance of any building permit, the petitioner shall submit a drainage plan to the Engineering Division of Public Works for review and approval. Such plan shall be in full compliance with the City of Newton Engineering design standards, contain all stormwater on site, and prohibit stormwater from discharging onto any abutting parcel or sidewalk.
- 4. No Building Permit shall be issued pursuant to this Special Permit/Site Plan Approval until the petitioner has:
 - a. Recorded a certified copy of this board order for the approved Special Permit/Site plan with the Registry of Deeds for the Southern District of Middlesex County.
 - b. Filed a copy of such recorded board order with the City Clerk, the Department of Inspectional Services, and the Department of Planning and Development.
 - c. Filed with the City Clerk, the Commissioner of Inspectional Services, and the Department of Planning and Development, a statement from the Engineering Division approving the final site plan.
 - d. Obtained a written statement from the Planning Department that confirms the building permit plans are consistent with plans approved in Condition #1.

- 5. No Final Inspection/Occupancy Permit for the use covered by this special permit/site plan approval shall be issued until the petitioner has:
 - a. Filed with the City Clerk, the Department of Inspectional Services, and the Department of Planning and Development a statement by land surveyor certifying compliance with Condition #1
 - b. Submitted to the Director of Planning and Development and Commissioner of Inspectional Services final as-built plans in paper and digital format signed and stamped by a professional land surveyor.
 - c. Filed with the Clerk of the Council, the Department of Inspectional Services and the Department of Planning and Development a statement by the City Engineer certifying that improvements authorized by this Order have been constructed to the standards of the City of Newton Engineering Department.
