

Note: Michael Engel joined the Committee to discuss his lifetime appointment as a trustee of the Chaffin Fund/Fig Newton Scholarship Fund. Mr. Engel is a School Guidance Counselor at the Madeline English School in Everett and lacrosse coach at Buckingham, Browne and Nichols School. Mr. Engel is an Auburndale resident, who also attended Newton North High School. He is looking forward to serving on the Chaffin Fund and helping students and families.

Mr. Engel has not attended a meeting at this point but has done some research on the Chaffin Fund and is aware that the Chaffin Fund contains a significant amount of money. Comptroller David Wilkinson informed the Committee that the fund's balance is over \$5 million. Committee members are pleased to have an educator as a trustee and asked how Mr. Engel learned of the opening on the Board of Trustees. Mr. Engel responded that Co-Chair of the Chaffin Fund Board of Trustees Beth Tishler recruited him.

Mayor Warren submitted the attached letter withdrawing and resubmitting Mr. Engel's appointment, as the City Council will not be able to take a vote before the 60-day action date expires on June 30, 2016. The appointment will be re-docketed to give the Council the opportunity to support the lifetime appointment of Mr. Engel. The Chair stated that Mr. Engel would not need to rejoin the Committee again for discussion of his appointment. With that, the Committee thanked Mr. Engle for serving the Community. The Chair suggested that Mr. Engel attend the next meeting of the trustees, even if it is scheduled before the Council takes an action on his appointment. Councilor Fuller moved the item no action necessary, which carried by a vote of six in favor and none opposed.
