

Why are you interested in serving on a board or commission?

I am writing to express my interest in being reappointed as a Member of the Zoning Board of Appeals (ZBA). I was appointed as an Associate Member of the ZBA in 2013 and was appointed as a full Member in 2018. Over the past eight years, I have sat as a hearing panel member on many matters. including many comprehensive permit applications under Mass. Gen. Laws c. 40B. I have enjoyed this experience thoroughly, and would very much welcome the opportunity to continue to serve, for the following reasons. First, I have come to see that the ability to evaluate zoning petitions fairly, thoughtfully, and critically is greatly improved with experience. With each hearing I have attended, I have become more adept at interpreting the zoning laws, identifying the key issues in a particular petition, and finding areas of compromise, where appropriate. Having gained this valuable experience over the past eight years, I am eager to put it to use in a way that furthers the values and interests of the City. Second, the ZBA currently is comprised of individuals with varied professional backgrounds, which, in my view, contributes to the Board's effectiveness. My background as a litigation attorney enables me to bring a unique perspective to the ZBA. Not only is there some substantive overlap in the work that I do professionally, but the skills I rely on daily as a litigator — i.e. the ability to apply the law to a particular set of facts, or to understand the strengths and weaknesses of a particular legal position — have proven to be quite valuable in my work on the ZBA. Finally, it goes without saying that zoning and housing issues are of critical importance in the City presently. While the role of the ZBA is to evaluate petitions dispassionately, and with only the law in mind, it is meaningful to me to play a small role in shaping the future of the community in which I grew up (NNHS Class of '97), and in which my wife and I are raising our two daughters (they are 12 and 9, and proudly attend Day Middle School and Franklin Elementary School). I am grateful for the opportunity to serve on the ZBA over the past eight years, and would be honored to continue to serve in this capacity in the future.
