Copy of Updated One Day Alcohol License Checklist

Many suggestions made to One Day Alcohol License Checklist. Suggestion to bulleted points under "For Catered Events" – eliminate and add additional major bullet points including a new one "If all alcohol license is sought, proof of non-profit status (e.g. 501(C)(3) or equivalent letter). Another additional major bullet point called "For events by state-licensed caterer"- Sub bullet underneath called "Above requirements do not apply", "Copy of caterer's license", "copy of menu", "Police Department and Health Department notified 48 hours before event". Commissioners suggest removing the "No state licensed caterer" major bullet and all sub bullets. ADD "non-"state license caterer. Needed clarification on "No state licensed caterer" if it is to remain on the checklist. Linda Walsh will be given the checklist for edits and the checklist will go on the January agenda.
