Continued Discussion Regarding Entertainment Licenses as Equitable

Commissioners asked for clarification on events that submit a request for only amplified/recorded music. Does the applicant need to appear before the commission or can the office do this administratively? This would be for an event planning only for background music, not live entertainment. Linda will get the answer from the office staff and/or law department.

Other business

The updated list of establishments, that recently received information about renewal, was given to commissioners. The office staff will plan to post this list electronically before the December meeting so the commissioners do not have to read the names into the record.

The updated State caterers list was given to the commissioners. The commissioner want to make sure the office staff checks this list with each application so the applicant knows if a local license is required. They suggested putting a adding an item to the check list. Sgt. Cupoli said if the applicant chooses a vendor off this approved list, even though they do not need an alcohol permit from Newton, they must notify the chief's office. Linda will review this with the office staff.

Linda explained the process for requesting additional licenses for all alcohol and wine/malt licenses, the request to ABCC must be made prior to March, this item will be placed on January agenda for discussion, currently there are no wine and malt licenses available (only all alcohol) for restaurants
