Re: FY2022-FY2026 Supplemental Capital Improvement Plan and FY2021 Projects to be Docketed

Dear Honorable Councilors,

Attached please find my submittal of the FY2022-FY2026 Supplemental Capital Improvement Plan (CIP) and the list of items for which the Administration expects to request funding in the remaining seven weeks of Fiscal Year 2021.

One of the top priorities of my Administration is to maintain and improve the City of Newton's infrastructure. Our school buildings, police and fire stations, parks, library, roadways, and emergency and public works vehicles are some of the many assets that require regular replacement and maintenance to continue to meet the needs of this active city. In order to plan funding for these projects, the City of Newton has created a Capital Improvement Plan, updated semiannually, that provides a five-year outlook for capital investments.

The submittal of this FY2022-FY2026 Supplemental Capital Improvement Plan comes at both a challenging financial time for the City due to COVID-19 pandemic revenue losses and a time of opportunity created by the Federal American Rescue Plan Act (ARPA). Newton is expected to receive approximately \$63 million in ARPA funding in several distributions with the funds incurred or spent before December 31, 2024. As outlined in both last year's Supplemental CIP and the FY2022-FY2026 CIP this past fall, the dramatic financial impact of the pandemic will continue to be felt into Fiscal Year 2022. This Supplemental CIP updates the City's CIP with proposed spending on critical projects that were previously deferred and important new projects that have arisen in the past six months, given both the City's needs and what the federal ARPA guidance appears to allow. We continue to carefully review the interim guidance on ARPA from the Department of the Treasury, 151 pages in length, that was released on Monday.

Last year during the pandemic, my highest priority had been to protect our core municipal and educational services and support our residents, businesses and non-profits. The City was not in a position to commit to significant capital investments last year, often funded with bonds that require payments over many years, given the financial risks the City faced. As a result, the Administration

made the disappointing but necessary decision to delay or put "on hold" most capital improvement projects and investments for a year. Only those with funding in place or those that were the most critical were allowed to move forward.

My goal is to use these significant, one-time ARPA funds to seed those initiatives that will help Newtonians and our villages not just stabilize and recover but permanently be a better place. We will invest these funds, not just spend them, to help make Newton more inclusive, more livable, more vibrant, more green and more sustainable in the decades ahead. We will invest these funds using the lens of equity, ensuring all geographic areas of Newton, all ages, all races, and all people are supported, with a special focus on those most hurt by the pandemic.

My focus regarding use of the ARPA funds, as guided by the Act itself, is to help those hurt in the pandemic, to spur our recovery, and to build a better Newton. We will use funds to respond to the public health emergency and its negative economic impacts (ARPA Section 1A) and for the provision of government services to the extent of the reduction in revenue due to the COVID-19 public health emergency (ARPA Section 1C). Not only do we need to jumpstart the City's economic recovery and the vitality of our village centers, but we need to be able to recover lost time on critical investments when revenue losses required us to defer investments.

This FY2022-FY2026 Supplemental Capital Improvement Plan (CIP) includes a significant number of revisions to the CIP presented in October 2020. There are seven new projects and three removed compared to the October 2020 document, leaving 213 total projects. Project revisions were made to the CIP where the urgency, prioritization, nature of the project, or a grant opportunity changed, or due to the potential of ARPA funding. Below is a summary of the most significant changes.

Significant Changes in the FY2022-FY2026 Supplemental CIP

Transportation Network Improvement Program – Increased Investments

This 10-year program, formerly called the "Accelerated Roads Program," had been funded at \$9.5 million per year for several years prior to the pandemic and in the FY2021 CIP presented in October 2019. The funding came from several sources — Chapter 90 state funded grants for street improvements, several accounts in the DPW operating budget, 2013 city override funds, free cash, and overlay surplus. Due to the sudden revenue drops last spring, the Fuller Administration was not able to use \$2.5 million in free cash to fund street improvements in FY2021. The total program budget was reduced to \$5.0 million in the final FY2021 budget.

A few weeks ago, in April 2021, the Fuller Administration docketed \$2.5 million, using ARPA's "Lost Revenue" funding to make up for lost City revenue and to boost economic vitality, to allow the Department of Public Works to do more major road projects, preventative maintenance of streets, sidewalk repairs and installations, as well as repairs on roads in very poor shape with Pavement Condition Index figures below 25. In addition, the Fuller Administration will also be docketing shortly \$400,000-\$500,000 in savings in DPW to bring the FY2021 program funding up to \$8.0 million. We are planning to use a combination of Chapter 90, operating budget funds, 2013 override funds, ARPA

funds, free cash, and other sources to return the Transportation Network Improvement Program and our complete streets implementation to an annual \$9.5 million budget in FY2022 and beyond.

DPW will finish two significant complete streets projects over the next several months - West Newton Square and Newtonville village center. Those projects combined cost \$12.7 million. We hope to undertake a Newton Highlands village center project in the coming years.

Library Children's Room Expansion - Project Restarted

ARPA funding to the City will allow the construction of this important project, with a design completed a year ago, to get back on track with a start in FY2022 or early FY2023. The Children's Room is a major draw for library users and is significantly undersized for today's programming needs. Library staff are determining the best time given post pandemic re-opening, the parking lot rehabilitation project and program timelines to begin the phased project expected to take a year to complete. Estimated project cost has been increased to \$2.0 million from \$1.75 million given the strong possibility that construction costs have risen over the past year.

Newton Early Childhood Program at the Former Horace Mann School – Project Restarted

The Newton Early Childhood Program (NECP) currently operates at 150 Jackson Road. Last summer a renovation had been scheduled at former Horace Mann Elementary School at 687 Watertown Street for the new home of NECP. The renovation was delayed last year because of the pandemic funding crisis. The difficult decision was made at the start of the pandemic to postpone the bidding and construction and the commitment to the project expenditure and debt payments. The City Council had approved \$13 million in project funding before the pandemic but that price tag may rise due to construction cost changes. While it is difficult to project costs accurately at the current time due to supply chain issues in construction, the current estimate is \$14.5 million. If the project cost comes in higher than \$13 million, it will return to the Council for approval.

Lincoln-Eliot School at 150 Jackson Road – Project Restarted

The feasibility and design work on this important project at 150 Jackson Road to develop a new Lincoln-Eliot School was put on hold last year since the NECP construction project had been put on hold as noted above; the NECP program must move out of 150 Jackson Road before construction there can begin. The project team for this Title 1 school project will be re-assembled shortly and begin to determine program needs and space options for the building and site for a high-quality teaching and learning facility. Given the timeline changes for the project, and the need to ensure a top-notch facility comparable to our other new/renovated schools, the project cost is now estimated at \$40 million. The goal currently is to have the Lincoln-Eliot in its new home open in 2025.

Franklin and Countryside Elementary School Projects – Schedule Change and MSBA Announcement The important Franklin and Countryside elementary school projects, both submitted in recent years to the Massachusetts School Building Authority (MSBA) for possible state funding, were moved back a year in last year's CIP along with most other school projects due to the pandemic. This April 2021, the MSBA announced that they were accepting the Countryside School into their Eligibility Phase for the Core Program, the first stage of their school funding program. The City will provide \$1 million in FY2022 for a feasibility study of this Title 1 school, using ARPA funds, as part of the MSBA process. Since the

design enrollment (and therefore building size) still needs to be determined with the MSBA, the current project cost estimate is broad, from \$50 million to \$60 million. The MSBA has generally funded about 35% of new school projects in Newton. The Franklin School project is also a very important project, although not likely to be funded by the MSBA. Using ARPA funds to jump start this project, a feasibility study will be started in FY2022-2023 to evaluate program, enrollment, space/facility options, and costs. The source of funds for the remainder of these two project costs is not determined at this time.

Horace Mann Elementary School Project – Funding Change

Newton Public Schools completed in November 2020 a feasibility study to assess existing conditions and space use, and to help develop a long-range space plan for a possible future addition at the Horace Mann Elementary School. The report's conceptual plan calls for an addition off the rear of the current gymnasium. Using ARPA funds to jumpstart this project, the City will undertake a more detailed feasibility analysis, including review of enrollment projections, beginning in FY2022-FY2023. The total cost estimate is \$12 million. The funding source for detailed design and construction is not determined at this time.

Ward and Underwood Elementary Schools Project – Funding Change

The system's two oldest schools, Underwood and Ward, will be reach their centennials this decade. Both schools have low enrollment, outdated and undersized facilities, are located on small NPS properties, with districts that are adjacent to each other. In early 2020, NPS began an in-house evaluation of the two schools, but that was put on hold due to the pandemic. While NPS may restart this evaluation process, the CIP includes feasibility study money using ARPA funds in the FY2024-FY2025 time frame.

New Projects

Seven new projects have been created:

- Newton North Field Lights With the heavy use of the NNHS fields and the recently approved start/end time shift at the high school level, there is an immediate need for field lights at Newton North's main field. These lights would be similar to the low light spillage, high quality LED lights recently installed at Newton South's main field. Funding will likely be a combination of fundraising, ARPA, and NPS/City funds. The cost estimate is \$500,000.
- Police Training Facility and Space Upgrades This project will focus on providing a 21st century adaptive police training facility and improved departmental operations and security. A feasibility study will take place in FY2022, design in FY2023 and construction in FY2024. This project is in addition to the ongoing HVAC project and the future Site Security/Parking Lot/Accessibility Improvement project. The total cost estimate is \$3 million.
- Rehabilitation of Athletic Fields— The City's athletic field infrastructure at both parks and schools need significant improvement. The Parks, Recreation & Culture Department is developing a longterm plan of field improvement projects for the next five years, with several projects going to the Community Preservation Committee for funding approval in 2021. The goal is to improve field quality and increase field use hours by rearranging fields, adding or improving lighting and

- rehabilitating the fields themselves. The total cost estimate for the five-year period is \$3.75 million, using a combination of CPA and ARPA funds.
- Upper Falls Northland Splash Park As part of their large mixed-use project, Northland
 Development will construct, and then turn over to the City, a splash park next to the Upper Falls
 Greenway and near Pettee Square. It is included in the CIP since it will become a City asset in the
 near future. The Parks, Recreation & Culture Department is meeting with the Northland team on
 the project to look at design and operational issues.
- Horace Mann Elementary School/Day Middle School/NECP Improvements (Safe Routes to School)
 <u>Project</u> This state funded project will upgrade the intersections of Crafts Street Albemarle Road
 and North Street Albemarle Road to improve bicycle and pedestrian accommodations near Day
 Middle School, Horace Mann Elementary School and the relocated NECP. State funding totals
 \$893,887.
- Replacement of Automatic Water Meter Infrastructure System The system connecting our water meters inside our homes and businesses to the Utilities Department's telemetry reading system is rapidly failing and needs replacement. The project includes the installation of transponders and the development of an online customer portal that would significantly improve resident/ business monitoring of water use and billing. The total cost estimate is \$4.5 million to be funded by the Water Enterprise Fund.
- Municipal Parking Lot Improvements Many municipal parking lots in village centers and other locations are in need of reconstruction, including accessibility and stormwater improvements. This \$3 million of investments will commence in FY2023 after the completion of the Pearl Street and Library parking lots, using a combination of ARPA, City bonding, and Stormwater Fund funds.

Project Cost Increases

After re-evaluation of future project scopes, revised construction estimates, actual bids being received, and/or the restoration of pandemic-era deferrals made in the fall CIP, a number of projects have increased costs:

- Reconstruction of Commonwealth Avenue from East of Auburn Street to Ash Street (Auburndale):
 State funding of construction has raised this project total cost to \$6,677,858
- Newton Early Childhood Program: Given uncertainties in the construction industry right now, the project cost has been increased from \$13 million to \$14.5 million
- <u>Permitting Software</u>: After the selection of Open Gov as the City's vendor, the Council passed a docket item for a project budget of \$1,137,285, up from \$750,000
- Horace Mann School Playground Improvements: The project cost was increased from \$150,000 to \$250,000 based in new in-house project cost estimates
- <u>Library Children's Room Expansion</u>: Given uncertainties in the construction industry right now, this has been increased from \$1.75 million to \$2.0 million
- <u>Levingston Cove, Shoreline Improvements at Crystal Lake:</u> As designs progress and with uncertainties in construction costs, the project cost estimate for this has increased from \$850,000 to \$1,000,000

- Halloran Field Lights and Field Reconfiguration Phase 1: The project cost has increased from \$800,000 to \$3,270,000 to incorporate significant field reconfiguration and improvement work and new estimates for light replacement and moves
- <u>Waban Hill Covered Water Storage:</u> After the bidding process, the Council approved the project at \$1,150,000, up from the \$900,000 estimate in the fall CIP
- <u>City-wide Municipal Vehicles and Equipment</u>: This program had been reduced in the fall CIP due the pandemic by \$500,000 a year for the FY2022-FY2026 period. These reductions have been restored back to the \$2 million per year spending level.
- <u>Transportation Network Improvement Program Paving/Sidewalks/Accessibility:</u> This program had been significantly reduced in the fall CIP due to the pandemic by several million dollars a year. These reductions have been restored back to the \$9,500,000 per year spending level.
- <u>Complete Streets Improvements Newton Highlands</u>: This has changed from a sole focus on improving Centre Street in the Highlands to a more comprehensive Highlands village center improvement project. As the scope has changed significantly, the project cost has increased from \$1,600,000 to an estimated \$5,000,000.

Notable Project Ranking Changes

Due to changes in project schedules and prioritization, some project rankings have changed since the October 2020 CIP. Notable larger changes include:

- Countryside and Franklin Schools have moved up from #75 and #74, to #41 and #42
- Horace Mann Playground Improvements has moved up from #78 to #44
- 25% Conceptual Design for Washington St Corridor has moved up from #83 to #43
- Pellegrini Park Field House Exterior Improvements has moved up from #136 to #54
- The West Newton Armory Reuse Affordable Housing has moved up from #97 to #56
- Horace Mann School Addition and Improvements has moved up from #108 to #68
- Ward/Underwood Schools Renovation/Replacement has moved up from #99 to #71
- Crescent Street Project Rehab and Expand Ford Park has moved down from #25 to #78
- Jeanette Curtis West Rec. Center (the Hut) has moved up from #163 to #103
- Newton South High School Mechanical Upgrades (Library) has moved down from #54 to #105
- Newton North Pool Air Handling Unit has moved down from #32 to #113

The two high school projects have moved down because of the significant investments in HVAC systems made by the City during the pandemic. The Crescent Street Project has been moved down waiting for the Council's Real Property Reuse Committee to revisit the future use of that property.

Project Deletions

The following projects were completed during FY2021, or have been determined to no longer be necessary, and have been deleted from the CIP:

- Citywide Financial Systems (MUNIS Conversion): project is completed
- Fire Pumper Truck Engine #2: project is completed

Mechanical Equipment Replacements – Various Schools: project is no longer needed after HVAC project this past fall/winter

List of Anticipated FY2021 Capital Expenditures

I am providing this list of items for which the Administration anticipates funding to be requested in the next several weeks remaining in FY2021. The items are in two categories, General Fund projects and Enterprise Fund projects.

FY2021 - General Fund Projects

- <u>Countryside School Feasibility Study</u>: In keeping with MSBA's schedule for the Eligibility Period, the City needs to obtain approval for the Feasibility Study, estimated at \$1.25 million, in the near future.
- <u>Transportation Network Improvement Plan:</u> \$400,000 in reclassified DPW savings will be docketed for addition to the road paving/sidewalks program.
- <u>Police Headquarters Mechanical Upgrades</u>: \$940,000 will be docketed for HVAC and communications infrastructure projects.

FY2021 - Enterprise Fund Projects

Replace Water Pipelines (multiple projects): The City funds water pipeline rehabilitation projects
using the MWRA's loan program. A \$20,837,000 docket item will be sent to the Council to cover
projects over the next five years.

We look forward to discussing these proposed changes as well as the FY2022-FY2026 Capital Improvement Plan as the Honorable Council deliberates during the Fiscal Year 2022 Budget review process.
