Mr. Koses provided a PowerPoint presentation attached to this report.

TC48-21 <u>DAVID KOSES, TRAFFIC COUNCIL CHAIR</u>, requesting to modify Sec. TPR-

194. Time limits in municipal off-street parking areas, and possibly to modify Sec. TPR-176. Parking regulations pertaining to particular streets, in order to move forward with a long-term trial of a parking permit plan for Newton Centre

employees. (Ward 6) [06/25/21 @ 2:36 PM]

Action: HELD 5-0. Hold for a trial to modify the regulations of selected parking meters in Newton Centre, in order to reserve certain parking meters for

vehicles that display a Newton Centre Employee Parking Permit. The number and location of reserved parking meters will be approved by the Commissioner of Public Works in conjunction with the Traffic Bureau Chief

and may be modified as part of this long-term trial.

Notes: Council members were provided with a presentation, site photos, and

recommendation.

Mr. Koses introduced the item, saying that it is intended to be held as a long-term trial in order to reserve parking for the employees of Newton Centre businesses. This project has already been discussed by the Public Safety & Transportation Committee and has received its approval. Mr. Koses said that there are already some employee permit parking programs in the city, such as for school staff at Newton North, Williams Angier School, and Horace Mann. There are also other employee permit programs in the villages, with the most recent one allowing Newton Highlands employees to park in the streets. Mr. Koses said that there are already some long-term meters in Newton Centre, but there have been many complaints over the years about the location of these meters, so some employees just feed the short term meters, which are located closer to some of the businesses. This trial is meant to try something new and to reuse the existing meters. The initial proposal is to reserve about 43 meters and to mark them with signage, though the number of reserved parking meters could change during the trial. Newton Centre employees will be able to obtain a free permit from the Traffic Bureau that must be displayed in order to use these

spaces, though the meter must still be paid. However, this permit does not guarantee that a reserved space will be available. Parking in these reserved spaces without a valid permit will be a parking violation. Mr. Koses said that the intention is for the trial to be held for at least a year and that parking spaces may be added or removed during the course of the trial.

No residents wished to speak about the item and public comment was closed.

Mr. Freudberg noted that when this trial was presented to PS&T, was there a discussion on changing the hourly rate of the meters. Mr. Koses answered that this has not been decided yet, but that the Planning Director has the ability to set the meter rates. The trial will allow the ability to try different things and see what works.

Councilor Bowman asked whether the six-hour meters were a lower rate than the two-hour meters as people are willing to pay \$0.75 an hour to park in employee spaces. Mr. Koses said that the rates are different and suggested that the easiest move to make would be to leave the rates unchanged, post the signage of employee parking and observe the effect. Councilor Bowman then suggested pointing out price differences for parking locations. Mr. Koses said that it would need to be determined where certain rates will be changed.

Captain Boudreau said the restricted spots would need posted hours of 8am to 6pm due to the Winter Overnight Parking Ban. Many of these lots fill up with overnight parking, so a later end time could accommodate employees and still ensure that there is no overnight parking.

Mr. Koses said that there are likely few employees in Newton Centre who would need to park overnight. If someone was working late until 9 o'clock for example, they can remain in the parking space until the overnight ban takes effect.

Councilor Bowman asked whether spaces assigned for overnight winter parking are marked, or whether it assumed that they will be empty. Mr. Koses said that he thought that anybody could park there provided they did not violate the overnight parking ban ordinance.

Mr. Koses said that the simplest action would be to reserve the meters as "Newton Centre Employee Permit Parking Only" between 8am and 6pm, with a sticker needed to park overnight during the winter parking ban. He repeated that as a trial, these conditions can be revisited and changed if needed.

Without further discussion, Mr. Koses motioned to hold the item for a long-term trial which carried 5-0.

Mr. Koses introduced the item, saying that it would install stop signs at multiple locations on Allen Avenue. This is a product of the traffic calming measures being implemented on the street. He said that these are all T-intersections, where no warrants apply and stop signs are not required, but there is no guidance that would prevent the installation of the stop signs.

No residents wished to speak on the item and public comment was closed.

Without further discussion, Mr. Koses motioned to approve which carried 5-0. This item may be appealed until the close of business on August 11, 2021.

TC47-21 <u>ISAAC PRIZANT, CITY TRAFFIC ENGINEER</u>, requesting to install a 'STOP' sign at the Druid Hill Road approach to Upland Avenue (Ward 8) [06/23/21 @ 8:41 AM]

Action: APPROVED 5-0. Approved the language of TPR 751. This item may be appealed through the close of business August 11, 2021.

Notes: Councilors were presented with a presentation, site photos, and recommendation.

Mr. Koses introduced the item, saying it was similar to TC49-21 as it also involves installing a stop sign on a T-intersection. He continued by noting that this item was docketed after a resident complained that vehicles do not stop and just continue driving through the intersection.

One resident spoke to say she supported the placement of this sign.

With no more residents wishing to speak, public comment was closed.

Mr. Fischman said the Upland Extension is a dead-end street, so he would not normally support a stop sign in this situation. However, he said that this spot has poor visibility on the corner so a sign may be a good thing.

Without further discussion, Mr. Koses motioned to approve which carried 5-0. This item may be appealed until the close of business on August 11, 2021.

TC46-21 JASON SOBEL, DIRECTOR OF TRANSPORATION OPERATIONS, requesting to approve Safety Zones at the following locations: Walnut Street between Hull Street and Austin Street, Albemarle Road between Watertown Street and Crafts Street, East Side Parkway, Brandeis Road in the vicinity of Newton South High School, [Dudley Road] and Ellis Street. Notes: Councilors were provided with a presentation, site photos, and recommendation.

Mr. Koses began the discussion, saying that the state legislature has recently approved allowing communities to approve the creation of safety zones, one of the few speed changes that municipalities can approve on their own. Safety zones are not substitutes for school zones, and are intended for certain areas with vulnerable populations, such as playgrounds, senior centers, and hospitals. He said that this item would formally add six new safety zones, including on two streets that do not have sidewalks. Mr. Koses said that the safety zones will receive a new section in the TPR.

Mr. Koses said several emails were received from Dudley Road residents in support of this item.

The meeting opened to public comment:

A resident spoke, saying he was familiar with the safety zone between Hull and Austin Street. He said that while drivers tend to speed between Cabot and Hull Street. The resident said he was opposed to safety zones for this reason.

Another resident said that she appreciated Dudley Road being added to this item as it will help make the area safer.

With no more residents wishing to speak, public comment was closed.

Councilor Bowman asked if these regulatory speed limits were listed elsewhere in the TPR. Mr. Koses said staff discussed this, and it was decided to modify TPR 84 to add clarity.

Mr. Fischman asked Captain Boudreau about enforcement during the trial and if it worked. Captain Boudreau replied that these areas were patrolled but that he did not have the exact statistics on hand. He continued by stating that if the item were to be approved, there could be extra enforcement of these areas. Mr. Fischman added that there is a noticeable difference between 20mph zones and 25mph zones.

Mr. Prizant said that he will be collecting more data on the safety zones and will have this available for comparison by the fall.

Mr. Koses added that the sign will make it easier to enforce speed limits in these areas. Mr. Prizant said that with enough signs it could change driver behavior, though more data is required to speak to the effectiveness of safety zones.

Mr. Freudberg asked about sign placement and Mr. Koses answered that the transportation superintendent has 25 years of experience on finding the best locations for signage. Mr. Koses said that sometimes, signage is not exactly where it is on the books due to field conditions. Sign clutter is also a concern.

Mr. Freudberg stated that Walnut Street going north into the safety zone is down a hill, making it difficult to break at times. He said that he worries that somebody will get rear-ended for not stopping soon enough. Mr. Koses said that starting the safety zone too far from the school would not meet the intent of the item. Mr. Prizant added that the minimum length of a safety zone should be at least a quarter of a mile and extend no more than 500 feet beyond a side street unless land use continues along the adjacent block. He felt a major shift was unlikely.

Councilor Bowman asked whether the Safety Zone could be extended further south, beyond the intersection of Walnut & Dexter, since there is a popular crossing on Dexter near Bullough's Pond. Mr. Koses stated that Dexter was too far to be included in the Walnut Street safety zone being discussed at this meeting, but that it could be addressed in a future item.

Without further discussion, Councilor Bowman made a motion to approve the request which carried 5-0. This item may be appealed until the close of business on August 11, 2021.

Without further discussion, Mr. Koses made a motion to approve which carried 5-0. This item may be appealed through the close of business on August 11, 2021.

Mr. Koses said that the School Committee recently voted to change the school start times, and that the purpose of the item is to update the TPR to reflect these changes in school start times and early release days. A few other outdated regulations would be updated as well.

The meeting opened to public comment.

One resident spoke about the signage on Beethoven, Walnut, and Elm that needed to be corrected. Mr. Koses clarified that he took the existing language in the TPR to modify it for changes that need to happen. Existing changes in the field were made due to trials resulting from the pandemic and have not yet been added to the TPR. These will need to be addressed through future items.

No more residents wished to speak on the item and public comment was closed.

Mr. Freudberg spoke to say that the restriction as experienced is only when the sign is illuminated. Mr. Koses said that the sign is illuminated based on the TPR language.

Without further discussion, Mr. Koses made a motion to approve which carried 5-0. This item may be appealed through the close of business on August 11, 2021.
