NECP Building Renovation Project (Re-bid)

THIS ADDENDUM IS TO: ESTABLISH ALLOWANCE FOR ELEVATOR SUBTRADE WORK AND ANSWER THE QUESTIONS BELOW:

General Bidders are instructed to complete the line item "Elevators" in Bid Form For General Bid #22-01 as follows:

Elevators _____ TBD _____ \$ 165,000 _____ Y__

Q1. Where are Sound Absorbing Panels, Section 098430, located?

A1. There are no Sound Absorbing Panels located in the Documents, disregard spec section.

Q2. There are 22 unit prices requested on the bid form. Of those, #2, 5, 6, 8, 9, 10 and 11 are work of FSB trades but there were no unit prices published with the file bid results. Please advise how these are to be handled?

A2. Item Sheet unit prices are to be provided by the General Bidders only. The purpose of the Item Sheet is to "set rates for supplies and services not included in the General Bid but which may be requested by the City after execution of the contract. Item Sheet prices should NOT be included in the General Bid and will not be factored into the General Bid award." See IFB p. 9.

Q3. Were there Unit Prices provided with the Filed Sub Bids?

A3. See A2. Above.

Q4. Are there Model #'s chosen for the Toilet Accessories to use as a basis for pricing?

A4. No Basis of Design is included for Toile Accessories, refer to Specification Section 102610 for requirements

Q5. The Corner Guards are noted on the Finish Legend but are not shown on the plans, where are they to be carried?

A5. Corner guards are to be located at outside corners of new GWB partitions in Student Areas; primarily at Small Group Rooms and Corridors. Location to be coordinated with OFOI cubbies; Assume (60) sixty corner guards.

Q6. Projection Screens (Section 115210) are in the specs but were not found on the plans (Projectors noted by Owner), do we have locations for those?

**A6. There are no Project Screen located in the Documents, disregard spec section. 115210. Marker and Tack Boards are called for the in A10.10: Material Schedule:

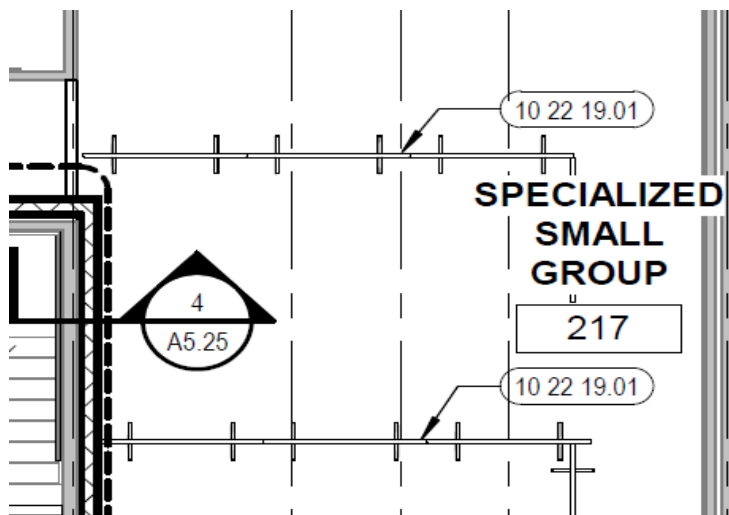
Q8. Acoustic Wall Panels (Section 098430) are in the specs, but were not found in the drawings, where are they to be carried?
