TC165-20 COUNCILORS LEARY AND GREENBERG, requesting to add EV Charging

Stations and/or EV Shared Vehicles into the Adams Street Parking Lot. (Ward 1)

[11/25/20 @ 2:37 PM]

Held 5-0 on 12/17/20. Held for a trial of the following: Up to two parking spaces in the Adams Street Parking Lot may be removed and replaced by a combination of spaces reserved for shared electric vehicles and spaces

reserved for electric vehicle charging.

Action: APPROVED 4-0 (Councilor Downs not voting). Approved the language of

TPR 760. This item may be appealed through the close of business October

13, 2021.

<u>Note:</u> Council members were provided with a presentation, site photos, and recommendation.

Mr. Koses said that this item was originally heard in December 2020 and held as a trial in order to get the EV chargers installed promptly. Since then, the chargers have been installed and he said that this item would make them permanent in the TPR.

No members of the public chose to comment on this item.

Mr. Koses made a motion to approve which carried 4-0 (Councilor Downs not voting). This item may be appealed through the close of business October 13, 2021.

TC160-20 <u>BRENDAN COHN</u>, 115 Jewett Street, Unit 3, requesting a parking prohibition in front of 399 Washington Street to enhance safety. (Ward 1) [10/23/20 @ 10:36 AM]

Held 5-0 on 01/28/21. Held for a trial of the following: No parking any time, Washington Street, north side, from Hovey Street to a point 85 feet easterly. This trial reduces the one-hour parking zone on the north side of Washington Street (7:00 a.m. to 8:00 p.m., excepts Sundays and Holidays) from Thornton Street to a point 85 feet east of Hovey Street, north side.

ACTION: APPROVED 5-0. Approved the language of TPR 761. This item may be appealed through the close of business October 13, 2021.

<u>Notes:</u> Council members were provided with a presentation, site photos, and recommendation.

Mr. Koses said that this was another item previously held for trial. This trial restricted parking at the intersection of Washington and Hovey Streets to provide safer sightlines. A no parking sign was added in administratively and the no parking zone was expanded up to 85 feet to the east of Hovey Street. Since then, Sunrise of Newton has been completed, and the building has its own garage. Now, on-street parking appears to be less utilized at this location. Mr. Koses said that the recommendation is to make the trial permanent, and to keep the 85-foot parking prohibition.

No member of the public chose to comment on the item.

Mr. Koses made a motion of approval which carried 5-0. This item may be appealed through the close of business October 13, 2021.

AP2-21 <u>DAVID KOSES, TRAFFIC COUNCIL CHAIR</u>, requesting to add the accessible parking space located on Washington Street at the accessible ramp leading to the Newton-Wellesley Hospital into the TPR. (Wards 4) [08/09/21 @ 2:49 PM]

APPROVED 5-0. Approved the language of TPR 762. TPR 762 adds two accessible parking spaces near the accessible ramp and removes one metered parking space. This item may be appealed through the close of business October 13, 2021.

Notes: Council members were provided with a presentation, site photos and recommendation.

Mr. Koses discussed this item alongside AP3-21. He said that Newton-Wellesley Hospital has installed a new ramp system from the sidewalk and Washington Street to the Hospital. Currently, there is one accessible parking space on Washington Street at this location, which includes signage, but it is not official as it is not currently included in the TPR. This proposal will formalize the existing space and also add a second accessible space which would require the removal of one metered parking space. Mr. Koses said that very high demand was observed for accessible parking spaces in this area, so they would see good usage. His recommendation was to approve both spaces. He also read a letter written by ADA Coordinator Jini Fairley in support of this decision (attached).

One member of the public spoke in support of adding the accessible spaces, saying that they used them frequently and that finding accessible parking is a challenge.

With no other residents wishing to speak, public comment was closed.

Mr. Koses made a motion to approve which carried 5-0. This item may be appealed through the close of business October 13, 2021.

AP3-21 JINI FAIRLEY, ADA COORDINATOR, requesting to add a second accessible

parking space on Washington Street, between 2000 and 2014 at the accessible ramp leading to the Newton-Wellesley Hospital, into the TPR. This will require the

removal of one parking meter. (Ward 4) [08/20/21 @ 1:18 PM]

Action: No Action Necessary 5-0.

Notes: See AP2-21.

Mr. Koses made a motion to vote No Action Necessary which carried 5-0.

TC61-21 DAVID KOSES, TRAFFIC COUNCIL CHAIR, requesting to review and

potentially modify the parking regulations along the portion of Ward Street between

Francis Street and Eastbourne Road. (Ward 7) [09/01/21 @ 12:47 PM]

Action: Held 5-0.

<u>Notes:</u> Council members were provided with site photos, a presentation, and a recommendation.

Mr. Koses introduced the item, describing the Ward Street area in front of the Temple Emmanuel. Parking is officially prohibited in a section of Ward Street on the north and south sides, but the signs are not posted and have not been posted in many years. Over the summer, a resident requested a review of the parking, and the City Traffic Superintendent found that the signs were not in compliance with official regulations. Signs were posted on Ward Street to comply with the official parking regulations. Members of the Temple Emmanuel community raised concerns about the loss of parking, so the signage was temporarily covered to allow for on-street parking along two sections of Ward Street during the Jewish High Holidays, with the knowledge that an item would be docketed in September to address this issue. In the meantime, a police detail was on hand during High Holiday events. Mr. Koses said emergency vehicle access is the main concern, as the street is only 28 feet wide. His recommendation is to maintain parking on the north side but to restrict it on the south side.

The meeting opened to public comment.

Multiple members of the Temple Emmanuel leadership spoke against this item with the following points:

- Temple Emmanuel has been located in its current spot for over 90 years with some leadership being with the Temple for 46 years. In all this time they have never been aware of emergency vehicles having trouble passing through Ward Street.
- Temple Emmanuel has always enjoyed a positive relationship with the Newton Police Department and hires a police detail whenever there are events of high traffic, such as the High Holidays or other notable occasions such as guest speakers and funerals.
- There is a significant population of elderly members who depend on nearby parking in order to access the Temple. Restricting on-street parking restricts their ability to use the Temple.

- Temple leadership is willing to recommit to its existing policy of notifying the police department well in advance of large events. Leadership also looks forward to working with the City to find a solution to this issue.
- Since 1997, there has been no signage restricting parking in this area and it has worked fine

Another resident from the area spoke, saying they were happy to have the Temple in the neighborhood, but said they were worried as a driver when cars parked on both sides of the street, even if only on rare occasions. She said that she experienced safety concerns over the years, and it can be hard and dangerous to exit the driveway with unpredictable drivers.

Mr. Koses said one email was received speaking in favor of removing traffic on both sides or at least on the south side of Ward Street.

Councilor Grossman said that she wanted to better understand the public safety concern and was also unaware of problems with emergency vehicle access. Mr. Koses said that this is a common concern throughout the City, and restricting parking due to the width of a street is not unique to Ward Street.

Councilor Laredo also spoke, agreeing with the Temple leadership, saying that the fact is that there has been no issue with emergency vehicles on Ward Street for decades, and this should be a consideration. There are many narrow streets in Newton that do allow parking because common sense is used to judge this on a street-by-street basis. Councilor Laredo continued by stating that during periods of heavy parking demand, the Temple hires a police detail, so there is no reason to change the parking regulation. He noted that the original complaint was only focused on replacing old signs. Councilor Laredo also added that there is no high parking volume outside of the High Holidays to interfere with garbage collection. Additionally, he said most of the congregation drives smaller cars anyway.

Mr. Koses reminded those in attendance that if Traffic Council approved the item, the option for an appeal remains open.

One resident asked if there were any regulations on street widths for safety concerns.

Mr. Prizant then spoke to multiple questions which were asked earlier. He said that different roadway classifications are established by MassDOT, with vehicle volumes serving as a main determinant. Though larger firetrucks can fit into some of these narrow streets, he said that scenarios can emerge where an emergency vehicle needs to find a gap such as a driveway to pull into. He said that emergency vehicle access is a valid concern from an engineering concern, but it is not the intention to diminish the concerns of the residents here.

Mr. Koses said that due to snow, vehicles may park closer to the median, further narrowing the street. Mr. Koses said that it is necessary to be proactive and that safety is the priority.

Councilor Downs suggested waiting to hear from the Fire and Police Department before making a final decision.

Captain Boudreau clarified that since this regulation is already in the books, just because the signs were missing, this does not mean the parking regulations were not in effect. However, he said the Police Department gives consideration during the High Holidays, and stays away barring a serious safety concern. He also said that he is currently unaware of any issues with emergency vehicles. Over five years there have only been three accidents in the area, with only two involving moving vehicles. However, they also want to be proactive and stop an incident from happening.

Mr. Fischman said that it would be a good idea to allow Temple Emmanuel to study this as well as to wait to hear from Fire Department and that it may be a good idea to have some locations on this road where cars cannot park. He said that with the Chabad on Dedham Street, a compromise on parking restrictions was reached.

Councilor Grossman said that it sounds like emergency vehicles have been already been using Ward Street without any issue and this precedent should be kept in mind for any action taken here. She also asked whether Ward Street could be addressed in different pieces

Mr. Koses noted that this proposal would only eliminate about four or six parking spaces.

Mr. Koses asked how comfortable Traffic Council members were with not posting a regulation currently in the TPR. Mr. Prizant said that there was a temporary suspension in place, which Captain Boudreau added is written to continue "at least" through the September 23 Traffic Council meeting, therefore, the status quo may remain for now.

Councilor Downs made a motion to Hold, to gather input from the Newton Fire Department. The motion carried 5-0.

TC62-21 <u>DAVID KOSES, TRAFFIC COUNCIL CHAIR</u>, requesting to remove the parking restrictions from the TPR for the west side of Westbourne Road. Mr. Koses said that parking is officially prohibited on the west side of this road, but parking occurs on both sides. This item would change the TPR to match these conditions in order to allow street parking to continue in this neighborhood.

No members of the public spoke on this item.

Mr. Fischman noted that in the photo, all cars were parked halfway onto the sidewalk as if the drivers were afraid of getting hit.

Mr. Koses made a motion of approval which carried 5-0. This item may be appealed through the close of business October 13, 2021.

TC59-21 <u>DAVID KOSES, TRAFFIC COUNCIL CHAIR</u>, requesting to change the following entry in Sec. TPR-150. Safety Zones, as approved on July 22, 2021: Dudley Road, and to add the following in its place: Dudley Road between Brookline Street and Boylston Street. Mr. Koses said that this was a product from a July Traffic Council meeting which included Dudley Road. This item corrects the action taken at the July meeting to clarify that the approved Dudley Road Safety Zone applies to the section of Dudley Road south of Route 9, and not to the small section of Dudley Road north of Route 9.

No members of the public spoke on this item.

Mr. Koses made a motion of approval which carried 5-0. This item may be appealed through the close of business October 13, 2021.

TC60-21 <u>DAVID KOSES, TRAFFIC COUNCIL CHAIR</u>, requesting to add the following traffic signals into the Sec 145 (c) of the TPR: Boylston Street (Route 9) eastbound offramp and Parker Street; Boylston Street (Route 9) westbound offramp at Parker Street and Clark Street extension. These signals are owned, operated, and maintained by MassDOT. Note that this item makes no change in the field and fixes omissions in the TPR. (Wards 6 & 8) [08/09/21 @ 2:49 PM]

Action: APPROVED 5-0. Approved the language of TPR 765. This item may be appealed through the close of business October 13, 2021.

<u>Notes:</u> Council members were provided with site photos, a presentation, and a recommendation.

Mr. Koses said that this item would include new traffic signals installed by MassDOT into the TPR to make them official.

Mr. Freudberg said that the section is not called Clark Street Extension. Mr. Koses said that he used the name in order to give the ramp a name to add it into the TPR.

A resident asked about the docket text only referring to off-ramps, not on-ramps. Mr. Koses said that this was not a concern as this is within the same location, and Traffic Council has the ability to make certain slight expansions to docketed items.

Mr. Koses made a motion of approval which carried 5-0. This item may be appealed through the close of business October 13, 2021.




Adams Street Lot Location Map (Slide from 12.17.20 Meeting)










Location of Washington Street near ramp leading to Newton-Wellesely Hospital




