Clerk's Note: The Chair of the Programs & Services Committee, Councilor Rice, reported on the item and stated that there will be a motion at the end of his report to move postponement of the item to a date certain of April 16, 2019, the next full Council meeting, to allow time for review and questions to be answered. He reported that the Programs & Services Committee was charged with evaluating the recommendations of the Charter Commission and to report back with recommendations to the full City Council. Since this was such a large undertaking, it was decided to create a sub-committee for the Charter. The Sub-Committee consisted of four members: two City Councilors who supported the Charter recommendations, and two City Councilors who were opposed. The sub-committee was chaired by Councilor Baker, and included Councilor Kalis, Councilor Krintzman, and Councilor Albright. There were a number of meetings of the Charter Sub-committee which presented its recommendations to the Programs & Services Committee also held several meetings which included public comment regarding the recommended changes. Following feedback, it was concluded that Area Councilors would not be included in the changes to the Charter.

There were other controversial items discussed in the Programs & Services Committee. The Charter Commission had recommended that the City Council should be able to hire its own Counsel on controversial items and the Charter Sub-committee agreed with this. The Law Department and the Executive Offices addressed this saying that the Law Department represents the City of Newton and there should not be separate Counsel for the Executive Department versus the City Council. The Programs & Services Committee did not agree and kept it in. There was also a recommendation from the Charter Commission that on a Referendum vote at least 20% of voters would have to participate in the election to make that referendum valid. The Programs & Services Committee changed that recommendation and made it 15%.

Major changes like the size of the City Council, and term limits for City Council were not tackled at this time. It was decided to separate those completely from the sub-committee and deal with them in the future. It was noted that there is a separate docket item to discuss a plan for eight at large and eight ward councilors. Chair Rice noted that if the full City Council approves these changes, they still must have the Mayor's approval before they are sent to the State Legislature.

The Chair of the Charter sub-committee, Councilor Baker, said a great deal of work was done to look through aspects of the Charter Commission's recommendations and to forward those that make sense for the city such as:

The Charter Commission reorganized some of the material in the Charter to make it easier to follow and understand.

The current provision for Special Elections says the election must be held forthwith. The recommended language provides more explicit detail.

The Charter Commission recommended that there be counsel to the Council. This would be legal counsel which would be used in an extraordinary situation when it was important to get independent advice. There are some technical corrections on how to deal with notifications.

Adding the powers of the School Committee to the Charter was included. Although they are set by state law, it was felt important to enumerate those. The Law Department was not enthusiastic about that.

The section on referendum were modified to include a requirement for more signatures than in the past and a required turnout for the election as a whole of at least 15% of the registered voters rather than 20% which was the Charter Commission recommendation.

Both the School Committee and City Council would have expenses reimbursed under a process to be set by ordinance.

A motion to postpone to April 16th was made and Approved
