- 1. Minutes from July 13 meeting approved
- 2. Newton police report Lt. Apotheker
 - This week: An officer responded to an organization in Newton where an individual believes he's being targeted because he's a white man who works with black and minority women. Their HR department did an investigation and found the allegations to be unfounded.
 - 9/2: A resident alleged his landscaper used anti-Semitic language in a phone conversation.
 - 8/13: An officer responded to an incident between a DPW driver and resident. The DPW
 driver alleged that the resident used a racial slur against him in a similar incident 2 years
 ago.
 - 8/11: A swastika was found on a whiteboard at NNHS. Police used a security video to identify the student who drew it. The principal of the school the student attends has spoken with student and their parents.
 - 7/24: A resident with a Black Lives Matter sign in his lawn reported that a white male drove by his home and yelled "race traitor" at him.
 - 7/21: One of the four doors placed on Newton Centre green was vandalized. This door was painted by an artist of Asian descent and one side had writing in Chinese.
 - No more reports of Asian homes being targeted for break-ins.
- 3. Complaints received Shin-Yi Lao
 - Complaint of harassment related to race and housing. Complainant was referred to MCAD and the Fair Housing Commission.
 - Complaint regarding an experience a resident had with the Newton Police Department. Complainant was given the contact information for the Officer in Charge.
- 4. Student reports Rachel Alpert-Wisnia and Ryan Chitty
 - Rachel: Students have expressed concern about an email that students of color at NNHS
 received over the summer. The email was from someone who was conducting a study
 on support students of color receive from teachers who are white. The students felt that
 more focus should be on hiring teachers of color.
 - Ryan: Nothing to report

- 5. Updates from the Mayor's Office Hattie Kerwin Derrick
 - Hattie has been appointed the City's LGBTQ+ Liaison
 - There has been a decision to make the MLK Day celebration virtual again this year. If you are interested in joining the planning group, contact Hattie.
 - There are several upcoming series planned with the library, asking HRC to co-sponsor.
