### **REQUEST FOR 50% REDUCTION OF RESTAURANT ALCOHOL FEES**

Mayor Ruthanne Fuller is requesting the Board of License Commissioners to reduce restaurant alcohol fees by 50% for 2022 to assist the industry in recovering from the impacts of the COVID-19 pandemic.

Commissioner Anil Adyanthaya ask if there was need to discuss the request further, Commissioner Dina Conlin answered that she did not see the need to discuss this much since it is a similar position when this request was brought up to the Commission back in 2020. Commissioner Conlin asked administrative staff Manuela Familia if half of the 2022 have been paid already. Manuela stated that the licensees paid full prices for the 2022 license renewals and that if the Commission

was to approve the 50% reduction refunds will have to be issued. Commissioner Conlin stated that despite of that fact she would be in favor of reducing the fees by a 50%. Commissioner Adyanthaya agreed and expressed how the restaurant industry is still being affected by covid19. Commission Chair McCarthy also agreed.

Commissioner Dina Conlin made a motion to vote to reduce the alcohol license fees by 50% for the calendar year 2022 for restaurant on-premises licenses and clubs. Commission Chair Kathleen McCarthy second the motion. Licensing Commission approved 3-0.
