The Rules & Orders of the Council contain a blackout period to avoid scheduling public hearings for Major Projects in July or August. The following petition was filed with the Clerk of the Council on June 12, 2017 during the June 1 to July 20 blackout period, the criteria for a Major Project classification involve a project that exceed six (6) residential units and trigger the Inclusionary Zoning Ordinance. The petitioner is requesting a suspension of the rules pursuant to Article IX, Section 1 of the Rules & Orders (3/4 vote) of the City Council to suspend the time restrictions to allow the petition to be assigned a public hearing for August 8, 2017.
