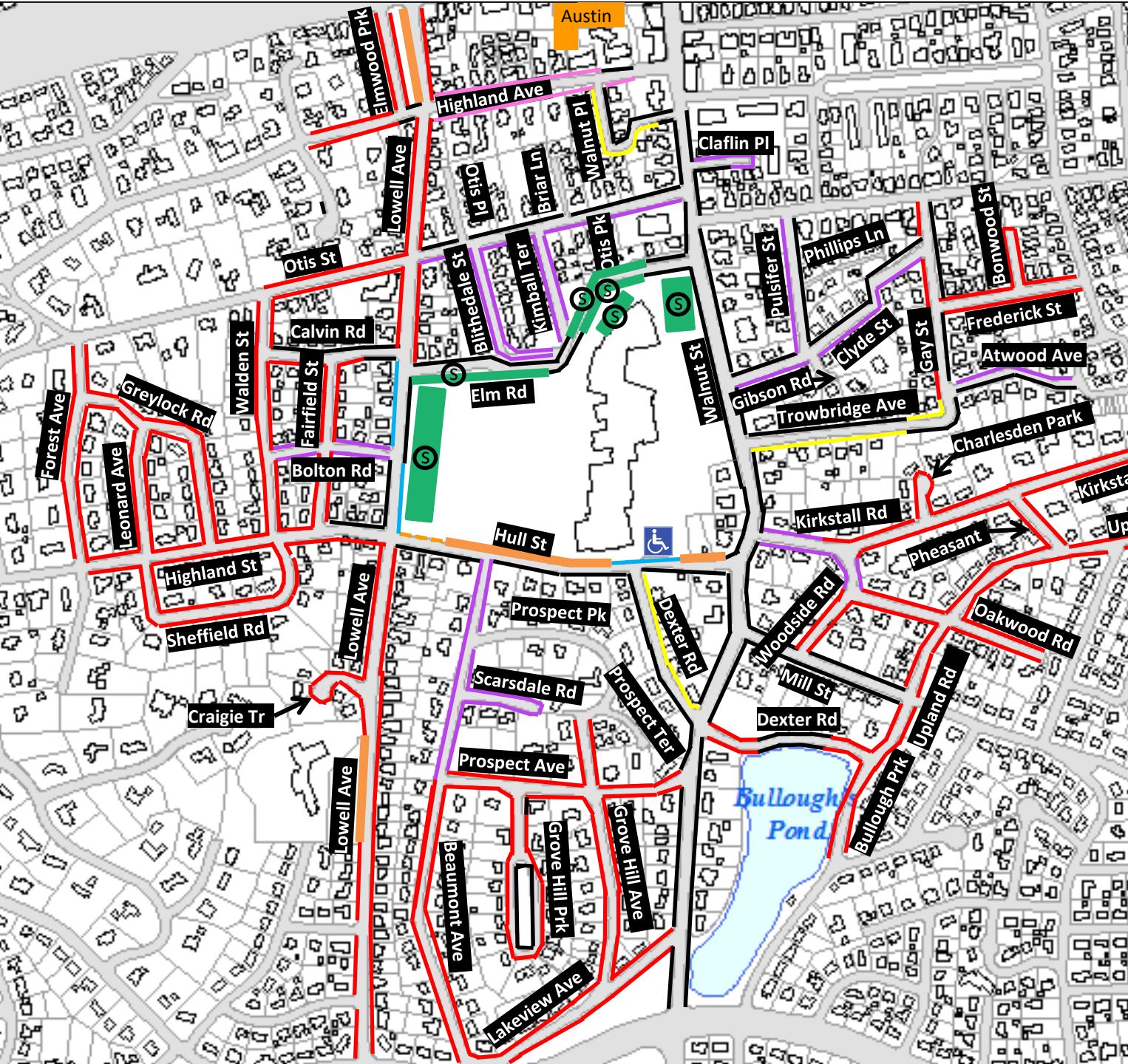

Newtonville Neighborhood Parking District Notes

All regulations are in effect on Newton Public School days only, unless otherwise noted*

**Parking regulations are in effect every day on Dexter Road, Trowbridge Avenue and Walnut Place.*

TIGER Drive is owned and managed by the School Department and is not a City-owned public roadway. Access to TIGER Drive is limited to NNHS visitors during the school day. From 3pm to 4:30pm access is specifically limited to Special Education buses and vans, people with valid handicap placards, Special Education families with passes and Plowshares parents. Left turns into or out of TIGER Drive are prohibited, and drivers may be cited with a moving violation. These access and parking regulations are enforced by Newton North staff and by the Newton Police Department, for the safety of our most vulnerable populations.

Newtonville Parking Permits & Guest Placards are available to residents living within the Newtonville Parking District.

Up to 150 **TIGER Parking Permits** are issued to NNHS Students to park in the following locations, as shown on the map:

- Much of Hull Street (observe posted signage, such as: accessible parking spaces, bus parking zone, pick-up zone).
- Two sections of the west side of Lowell Avenue: abutting Elmwood and Claflin Parks (observe posted signage).
- Austin Street Parking Lot (see the ongoing Traffic Council trial, **described below**).

Note: Students may not park on **Elm Road, or in the Lowell Lot, Walnut Lot or Theater Lot** during school hours.

Students should not park on neighborhood streets during school hours.**

All-day parking is provided in the Austin Street Parking Lot, at a cost of \$5.00 per day.

** City Ordinance Sec. 19-181 (b): “Vehicles parked within any non-metered time-restricted parking space must be moved to a location beyond the nearest intersection ... before the expiration of the posted time limit and may not return for two hours.” See Section 19 for additional parking rules.

The following streets are private ways & are not part of the Newtonville Neighborhood Parking District: *Briar Lane, Gibson Road, Otis Park, Phillips Lane, Prospect Park and Prospect Terrace.* Otis Place is primarily a public way but is not part of the Newtonville Parking District.

To respond to changing conditions brought on by the COVID-19 Pandemic, Traffic Council voted to allow the following long-term trials:

1. Authorized access only onto Elm Road on School Days.
2. Parking with a valid TIGER Permit is allowed in the Austin Street Parking Lot, with no payment required, any time, on **SCHOOL DAYS ONLY**.
 - May park in **ANY** regular parking space inside the Austin Street Lot, not include accessible parking spaces.
3. A Pick-Up/Drop-Off Zone was created on Lowell Avenue, 7:00 a.m. to 4:00 p.m., School Days.
 - *Southbound: Elm to Bolton; Northbound: Hull to Bolton*
 - No idling and motorists **MUST** remain in the vehicle.
