

Dear Paula,

I am writing to provide a value estimate for the remaining sections of the Newton Centre mosaic sculptures created by Lilli Ann Rosenberg. Given their current condition as broken cement sections that still contain intact ceramic and glass elements, I value them at approximately \$250. Their value lies primarily in the ceramic elements, which could be repurposed for a future mosaic, in their identity as creations of Lilli Ann Rosenberg, an acclaimed local artist, and in their sentimental value as pieces of a collaborative art project created generations ago.

I am able to provide this valuation based on two decades as a mosaic artist, as a facilitator of present-day collaborative art projects, and as a staff person at the Beautiful Stuff Project, a creative reuse center that often has to assign value to materials that are no longer needed by businesses but might become future works of art. In these capacities I consider the inherent value of the materials themselves as well as the time that was spent creating the artwork balanced with the time that it would take to resurrect the artwork. In the case of the damaged pieces of sculpture, the cement and ceramic themselves have no resale value and the piece cannot be resurrected in its current form, but the time that went into its creation and maintenance have some value.

Thank you for finding a way to maintain the sentimental and historical value of the piece for future generations.
