1. FY23 Annual Action Plan Public Hearing

The City of Newton and the WestMetro HOME Consortium, consisting of twelve other member communities (the Towns of Bedford, Belmont, Brookline, Concord, Lexington, Natick, Needham, Sudbury, and Wayland and the Cities of Framingham, Waltham, and Watertown), are required by the U.S. Department of Housing and Urban Development (HUD) to prepare an Annual Action Plan that describes Community Development Block Grant (CDBG), HOME Investment Partnerships Program (HOME), and Emergency Solutions Grant (ESG) funded projects that will be undertaken over the course of the upcoming fiscal year (July 1, 2022-June 30, 2023) as part of the goals and strategies outlined in the FY21-25 Consolidated Plan. The City of Newton and WestMetro HOME Consortium are holding a public hearing on the FY23 Annual Action Plan to solicit feedback and ensure grant funds are effectively spent to assist low- and moderate-income residents.
