1. Introductions (6:00-6:05)

The meeting started at 6:05 with 7 members in attendance (Eileen, Rob, Darby, Sandra, Nancy, Jane, Matt). Lucie and Barbara arrived during the meeting in progress.

2. Approval of the May 9, 2022 Meeting Minutes (6:05-6:10)

Eileen asked if there any comments or changes for the minutes for the May COD meeting. Hearing none, Darby made a motion to accept the minutes as read and distributed. Jane seconded the motion. The motion passed unanimously by a vote of 7-0.

Taken out of order (was originally #12 on the agenda:

3. Updates from the Co-Chairs (8:10-8:30)

Eileen wanted to share a change of status with regard to her membership on the COD. She said that many of you know she has been talking about mental illness and how we need to bust the stigma and be a more welcoming community, but never shared that she has had major depression for a long time, under control with medication. She felt that she was talking the talk but not walking the walk. Originally she joined the COD as a family member of adult children with disabilities, but not as a person with a disability herself. Thus she is changing her status on the COD as a member with a disability, with mental illness. She also mentioned that Anne Marie had hoped to attend tonight, but is not feeling well, still recovering from Covid (for a second time). Jini also announced that 2 COD members are no longer on the COD, Warren Abramson (not reappointed) and Girard Plante (resigned). She said that there were at least 4 applicants, attending COD meetings, being interviewed, and she and Eileen will keep everyone posted when new members are appointed by the Mayor.

4. CDBG Report (6:10-6:15)

Nika gave the CDBG Access Projects report, which can be viewed on page 6. Sandra observed that a new curb cut was installed at the intersection of Langley/Warren/Chase, as a result of a new house going up on the corner. She wanted to know if that new curb cut lines up with the plans for the FY23 CDBG project. Nika will get back to the COD once speaking with DPW. Sandra also asked for the status of McGrath Park. Nika said there was no update but will get back to the COD next month.

5. Prioritization of FY24 CDBG-Funded Access Projects (6:15-6:30)

Nika led the discussion to arrive on an area to consider CDBG access projects for FY24 funding. The 4 areas are: Infrastructure, Parks, public buildings, and non-profits in Newton. Members looked over the previous projects recommended in the past few years that have not been funded as of yet, and the areas that were priorities in the past 4 years. Rob shared the priorities for a CDBG-funded project recommended by the Funding Subcommittee, which were the cross walk and 2 curb cuts in front of City hall and Phase 2 of the Dexter Walnut intersection.

Each member had one vote to cast for one of the 4 areas, from which an access project will be chosen in January. The votes were:

7 for Infrastructure and Lucie (who joined us during this agenda item) abstained. Due to this voting, FY24 CDBG-funded access projects will come from Infrastructure,

mainly curb cuts and RRFBs. Jini also mentioned the 2018 ADA Parking Lot audit conducted by IHCD, the COD may want to consider improvements for access at one or more of them. Matt asked about whether there would be any accessible improvements where Temple Raim is located, as they are planning for expansion there, with housing, etc. Jini said she always likes suggestions from members as to what developments they would like to have on a future agenda, as there are so many, it is best to be suggested from a COD member. Jini will look into this development.

6. Accessible Fines Reports (6:30-6:40)

Captain Boudreau gave the 2 Fines reports which can be viewed on pages 7 and 8.

7. Treasurer's Report (6:40-6:45)

Jane gave the Treasurer's Report which can be viewed on pages 9 and 10. She reported that there were no changes to the balances of the COD accounts since last month's report.

8. ADA Coordinator's Report (6:45-6:55)

Jini gave the report of her ADA activities for the month of May. Her report can be viewed on page 11. Jini highlighted a few key site visits and meetings. She described reviewing a way one of the contractors were making an interim accessible pathway with sidewalks under construction. Rather than taping and coning off a section of sidewalk excavated but not yet ready for new concrete, the contractor filled in with material like stone dust and smoothed out the transition from the nearby sidewalks. Her second site visit was to walk through the many fields at Albemarle Park to understand some of the proposed concepts for reconfiguring the fields and to provide accessible paths throughout. Jini reported on the City Council meetings where an option was being chosen for the MassDOT proposed of the Commonwealth Ave Carriageway, from Ash St. to Auburn St. In the end, the Council voted to choose option 3, keeping the complete renovation of the Ash and Commonwealth intersection, making it accessible for the first time.

9. Ideas/Projects for MOD's Grant (6:55-7:15)

Jini was soliciting ideas as to a project she could apply for to the MOD ADA Improvement grant program. Newton already received one of these grants in 2019 for the installation of APS units in 14 signalized intersections. Subsequently, the city appropriated CIP funds to complete the goal of making every signalized intersection accessible, when a visual signal existed for pedestrians. There was some discussion about looking at the newly completed sidewalk inventory, which is being reviewed for accuracy before making public. If there are critical sidewalks needing widening or repair, it is possible that could be considered. At this point, the members did not propose a specific project.

10. DPPC Presentation (7:15-7:35)

Sarah Nechamen, Outreach Coordinator for the Disabled Persons Protection Commission (DPPC), gave an excellent presentation about who they are, what they do, and their hotline, with regard to reports of abuse (physical, sexual, emotional, and

financial) or neglect by a caregiver of an adult with a disability between the age of 18 and 59. The presentation can be found on pages 12-14. There is no statute of limitations, if you just heard about abuse that happened 10 years ago, for example, it can be reported to the DPPC.

The abuser can be a professional or a family member or friend/acquaintance. For more information, you can check out their online presence at:

www.mass.gov/dppc. You don't have to have proof of abuse, suspicion is sufficient. The DPPC investigators will do that. These investigators are fact finders, civil investigators, not criminal investigators, however they will involve the Police if they feel a crime has been committed. Sarah covered who are mandated reporters and their responsibility to report abuse. A new registry of abusers has recently been organized. She offered to have a DPPC representative attend any events organized by the COD, such as at the Harvest Fair at the COD's table. Lucie commented that she feels like DDS investigates themselves when a report/complaint is referred to DDS, for example abuse of an individual in a group home, rather than DPPC keeping it. Sarah said often it is the agency who may have more expertise to investigate a report of abuse. The newly formed registry is used by DDS before hiring anyone. Sarah said that there are about 14 or more abusers listed, and 14,000 searches of this registry to date.

- 11. Potential Events for Mental Health Awareness (7:35-7:50)
 Jini described an upcoming PBS documentary, "Hidden in Plain Sight", about mental illness, see flyer on page 15. It is slated to be shown at the end of June and Jini has a contact to potentially have a film screening for an event, perhaps in October. Eileen has contacted the Me 2 orchestra but hasn't yet found out the cost or available dates. Discussion about a venue, and Hattie pointed out that the War Memorial Auditorium would be possible, can do a Hybrid event, holds about 150, and the ventilation has been improved, for anyone having Covid concerns. A date would need to be reserved several months in advance. Eileen will get back to the COD about this possibility.
- 12. Updates- Funding & NWH Subcommittees (7:50-8:10)

Rob gave an update for the Funding Subcommittee. They met last month, on May 16, and besides the recommendations for CDBG access projects for FY24, the committee also talked about how people with disabilities on a very low income can qualify for some of the new housing developments' affordable apartments. The next meeting is June 27 at 3:30PM on Zoom.

Sandra announces the next quarterly meeting of the NWH Subcommittee will be June 21, at 11am. All are welcome and she would like to invite more COD members to join the committee and/or attend these meetings with NWH staff. Some of the agenda items are about whether they have both adjustable/accessible exam tables as well as testing machines, such as X-ray, MRIs, Mammograms, etc. Both Jane and Nancy related recent experiences with NWH regarding unavailability of adjustable tables for testing, and the lack of clear masks for in-patients who are hard of hearing and read lips. Both issues will be brought to NWH staff at the June meeting. Sandra mentioned that last weekend, both sides of the West entrance driveway had the sidewalk under repair, with no pedestrian accommodations, especially for people with mobility disabilities or who are blind. Rob wanted to point out that other hospitals have entrances that do not require a

pushbutton to push to get in, that the door automatically when a person approaches. This does exist at the Emergency entrance, but not at the West entrance. Sandra said they will add this issue to the agenda.

13. Adjournment (8:30)

The meeting adjourned at 8:15PM.

end June 30th.

FY22 McGrath Park Perimeter Path Installation – (CD22-03A; Budget: \$91,300.00; Expended: \$0; Balance: \$91,300.00) Constructing an accessible perimeter path around Richard McGrath Park. PRC has finalized a contract with CDM Smith Inc., to be the designer architect for

this project.

FY23 Langley/Warren/Chase Crossing -

Installation of accessible crossings at Langley Rd. and Warren St. This includes a bump out on the northeast corner of the intersection to create the space

needed to install a curb cut to cross Warren St. Planning staff has collected demographic information at this location for the FY23 Annual Action Plan.
